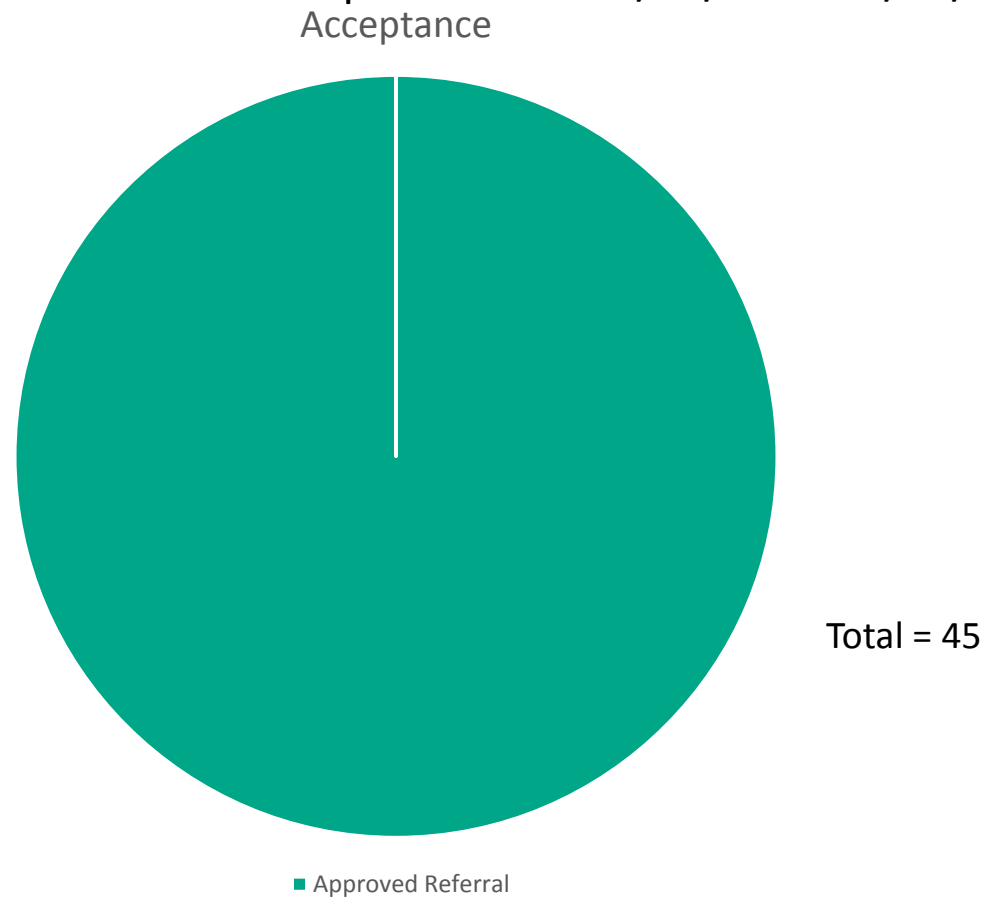

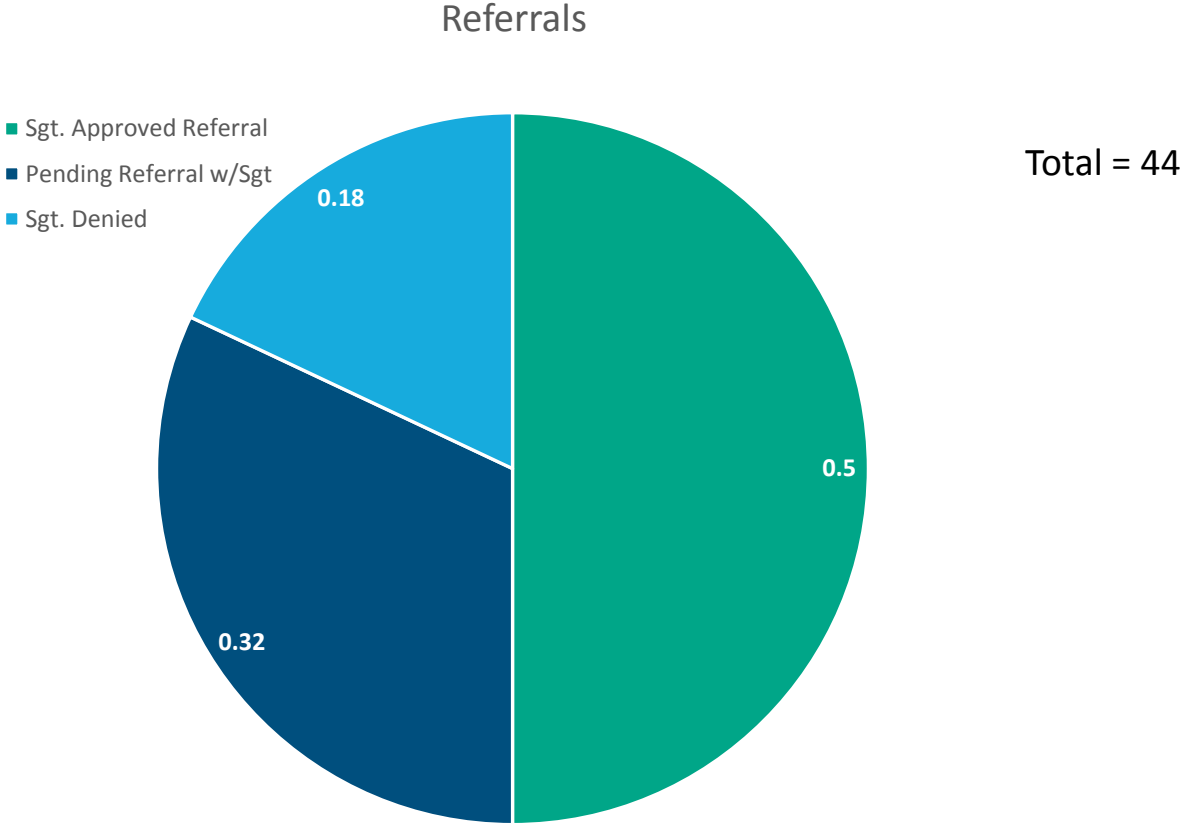

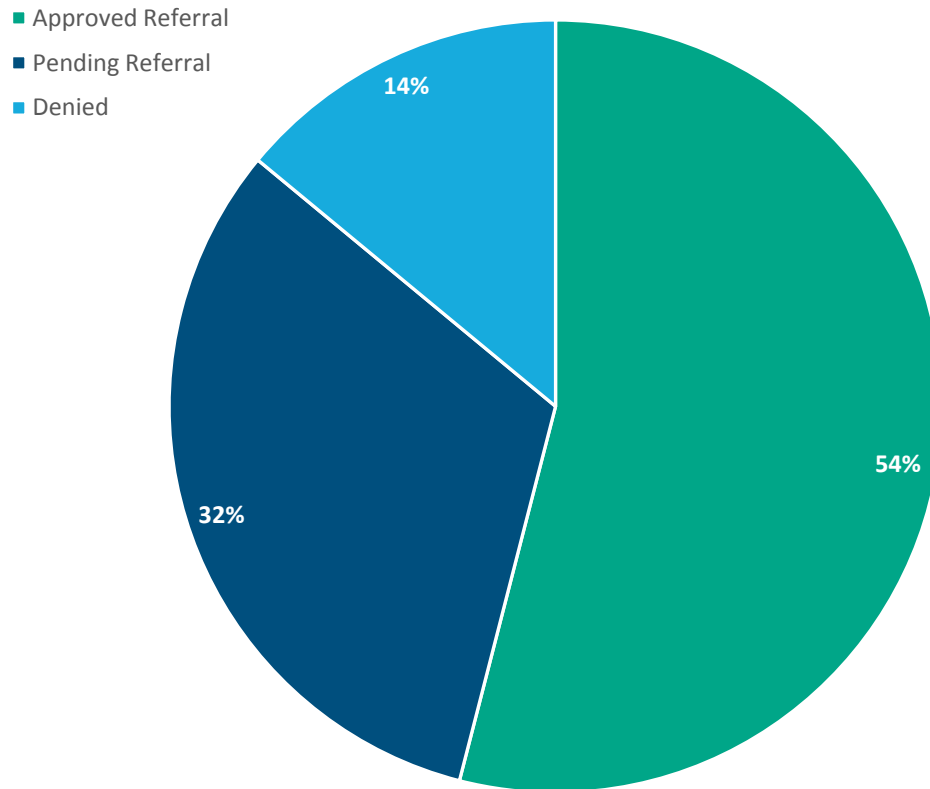
Seattle LEAD Arrest Diversion Referral Acceptance Rate 10/01/23 to 11/30/23

Seattle LEAD Community Referral Rate 10/01/23 to 11/30/23

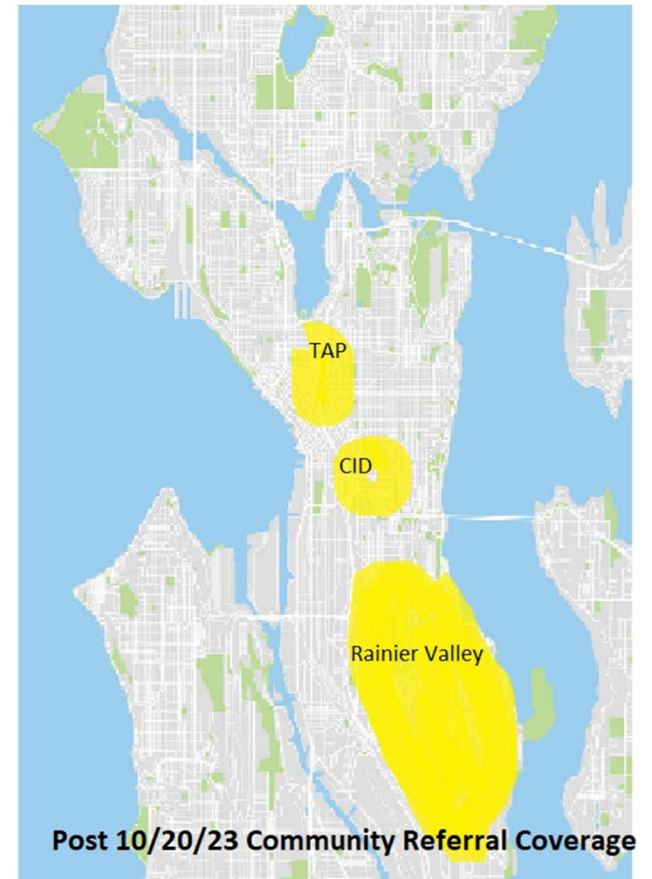
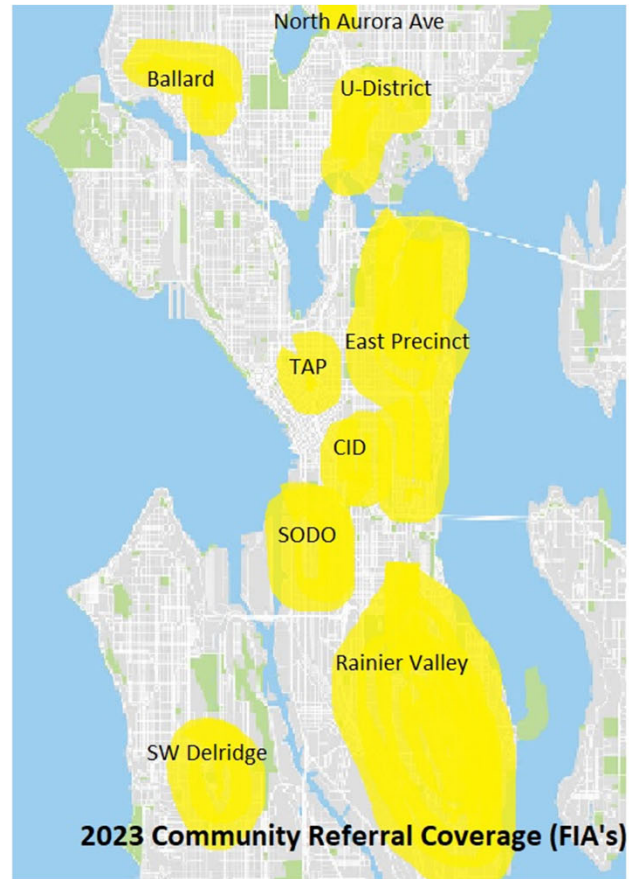
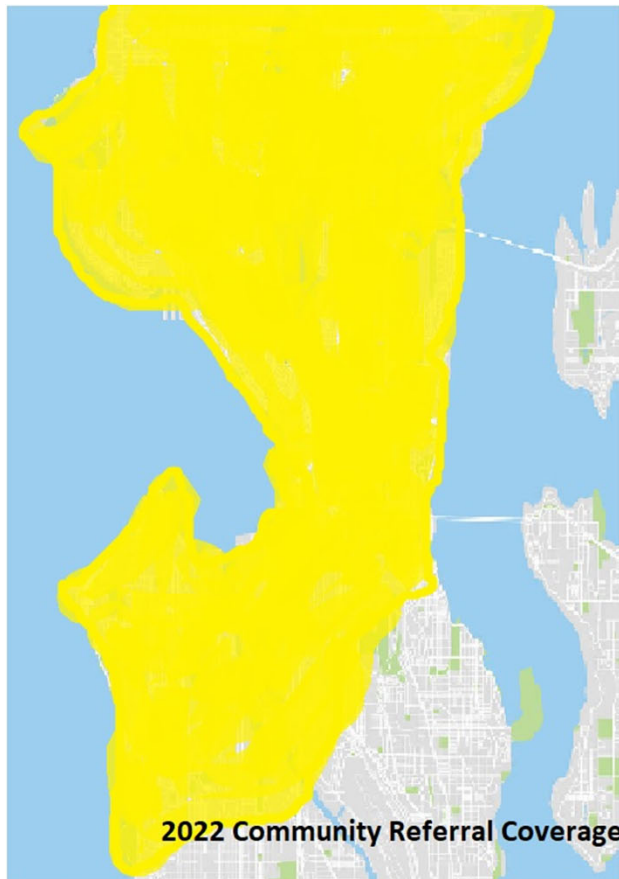


87 percent of all accepted community referrals come from just three areas:

- Upper Third Avenue

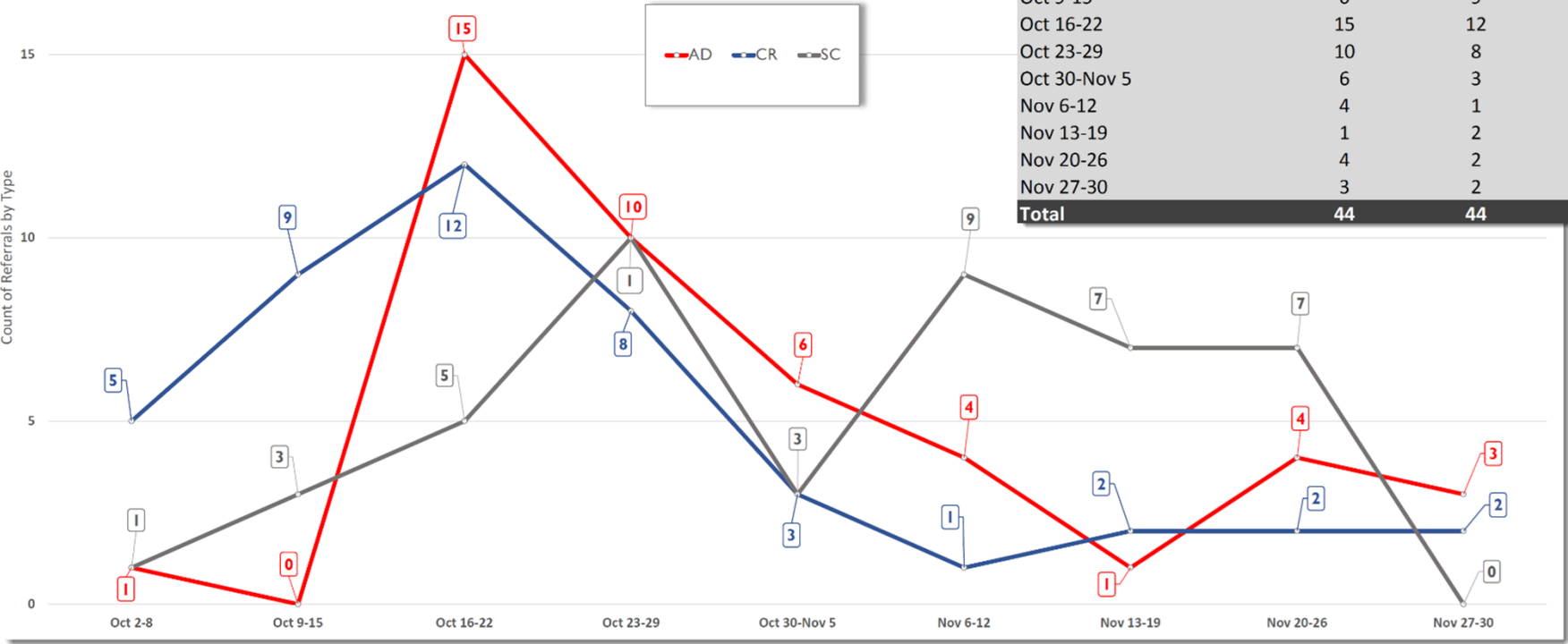


Seattle LEAD Community Referral Coverage Map

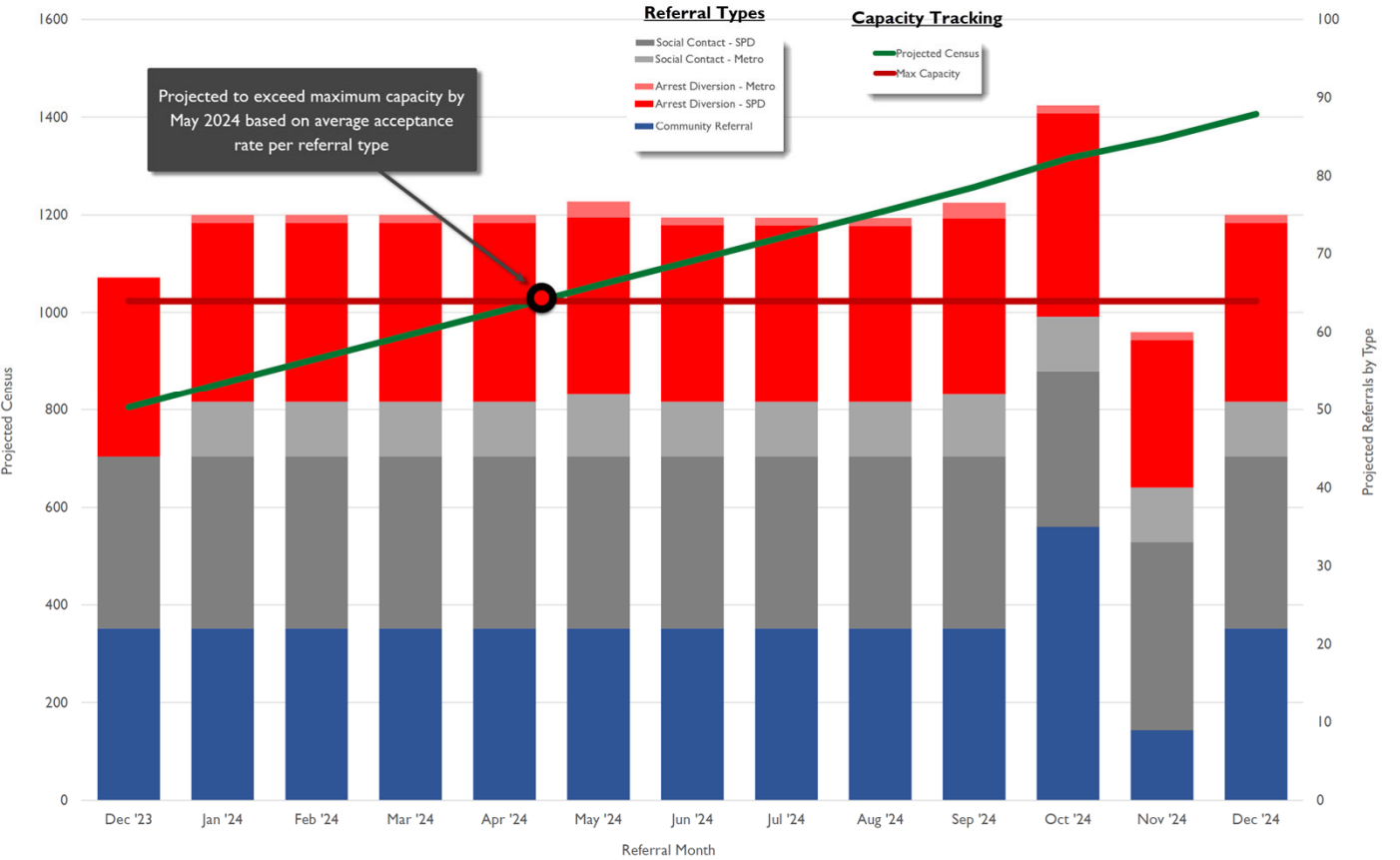

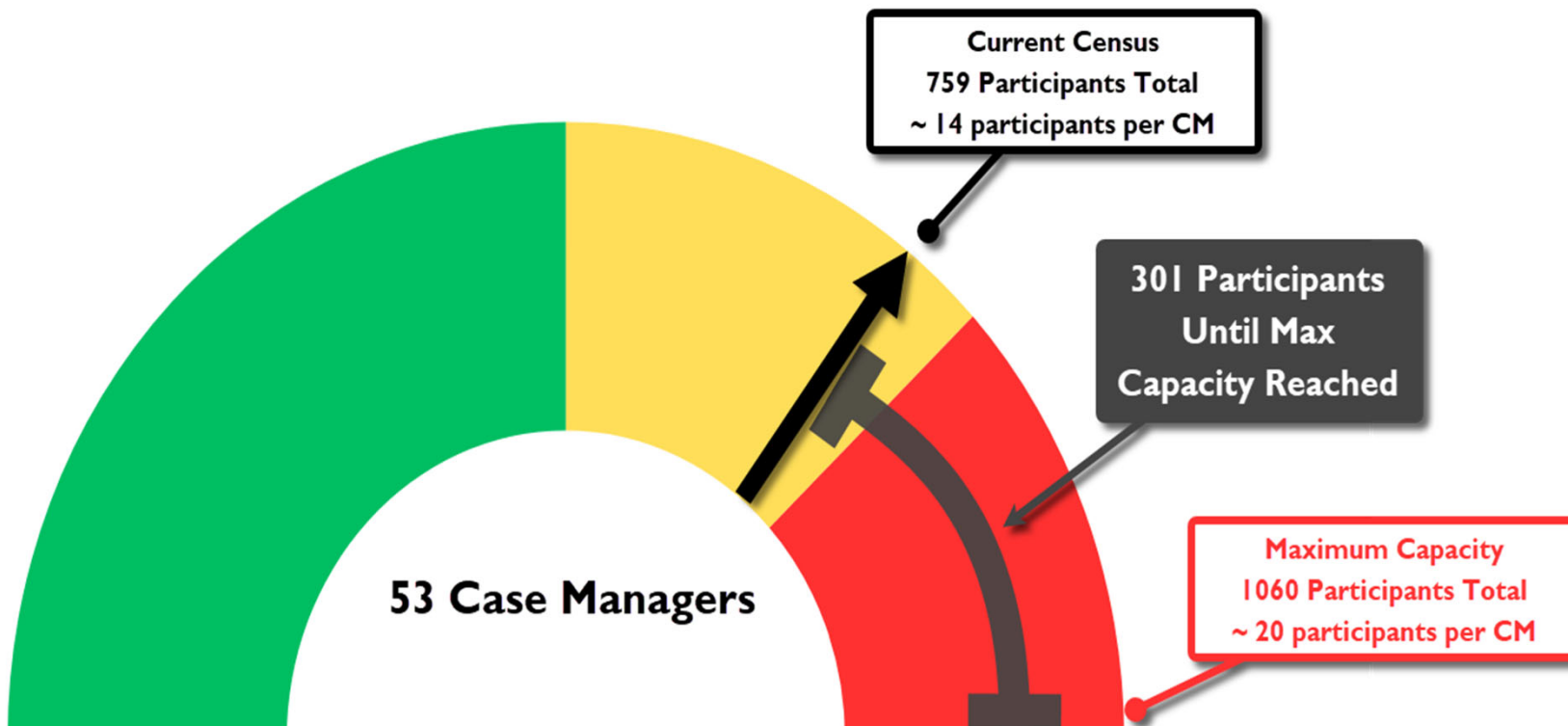
Seattle LEAD Projected Census Based on Average Acceptance Rate

I. Annual Surveys

- Universal Survey of 27 questions
- Tailored Surveys for Each Technology
- Auditees Complete Survey by Deadline

Example Survey Questions

- Is the technology used to record audio?
 - Yes
 - No
- Under what circumstances is it likely that risks to violating civil liberties exist in the use of the technology?
 - Rarely, if at all
 - Through improper use
 - Through proper use
- Approximately how many individuals are subject to the surveillance annually?
 - Fewer than 10
 - Between 10 and 99
 - Between 100 and 999
 - More than 1,000

II. Risk Scoring

- Review the Surveillance Impact Report (SIR)

Example Survey Questions

- Is the technology used to record audio?
 - SIR
- Under what circumstances is it likely that risks to violating civil liberties exist in the use of the technology?
 - SIR and/or prior compliance review
- Approximately how many individuals are subject to the surveillance annually?
 - Auditee survey and/or prior compliance review

- Each technology's risk score ranked
- Important considerations integrated
- Consolidated Risk Memo as the Published Annual Review for all technologies
- Consolidated Risk Memo identifies internal controls designed to reduce risks

IV. Compliance Review

- Depending on the considerations identified in the consolidated risk memo, OIG will select technologies
- The current design of the Universal Survey (27 questions) makes it impossible for technologies to not be reviewed every 3 or 4 years
- Compliance Reviews test internal controls designed to reduce risks
