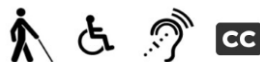

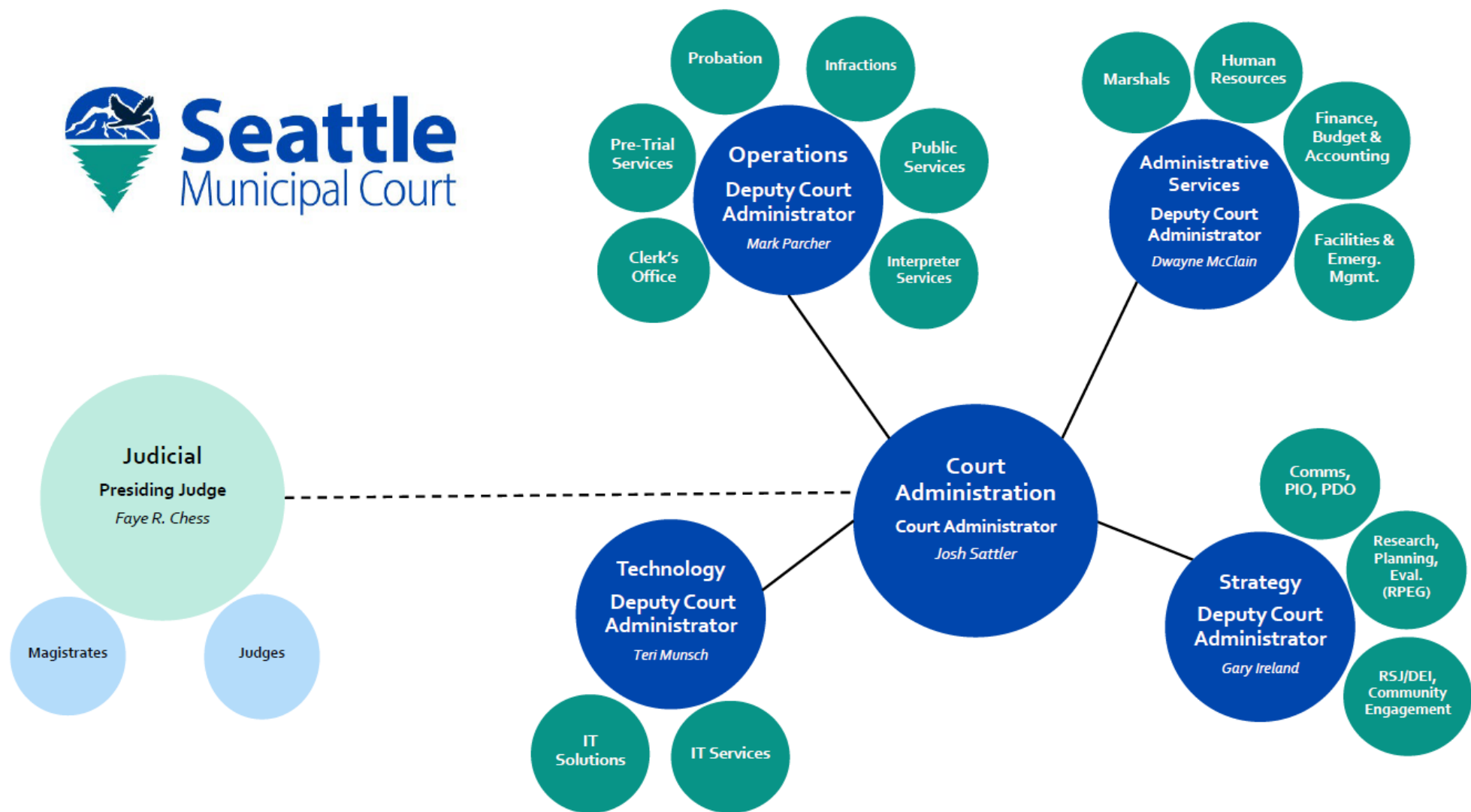
Mission: To provide a forum to resolve alleged violations of the law in a respectful, independent, and impartial manner.

Seattle Municipal Court

- The judicial branch of Seattle City government.
- Authorized under Revised Code of Washington (RCW) 35.20.
- Adjudicates misdemeanor and gross misdemeanor offenses, infractions, and civil violations under the Seattle Municipal Code and Revised Code of Washington statutes.
- 7 elected judges, 5 appointed magistrates, 4 service areas.

Budget Snapshot

FY 2024

General Fund Support	\$43,461,894
Full-time Equivalents	201.85

SMC Budget Reductions

FY 2020	3% (\$1.08M) mid-year savings
FY 2021	5% (\$1.8M) reduction (primarily in Probation)
FY 2023	3.2% (\$1.27M) reduction + ongoing \$275K vacancy savings commitment

Court Programs

Therapeutic Courts: Mental Health Court, Veterans' Treatment Court, Domestic Violence Intervention Program, Ticket Debt Reduction, Youth Traffic Court.

Pretrial Services: Assist individuals navigate the court system, follow through with their case, and complete their court obligations by reducing barriers and referring to community supports and services through the **Community Resource Center**.

Alternatives to Incarceration: Electronic home monitoring (GPS), drug and alcohol screening, and **Probation** counseling.

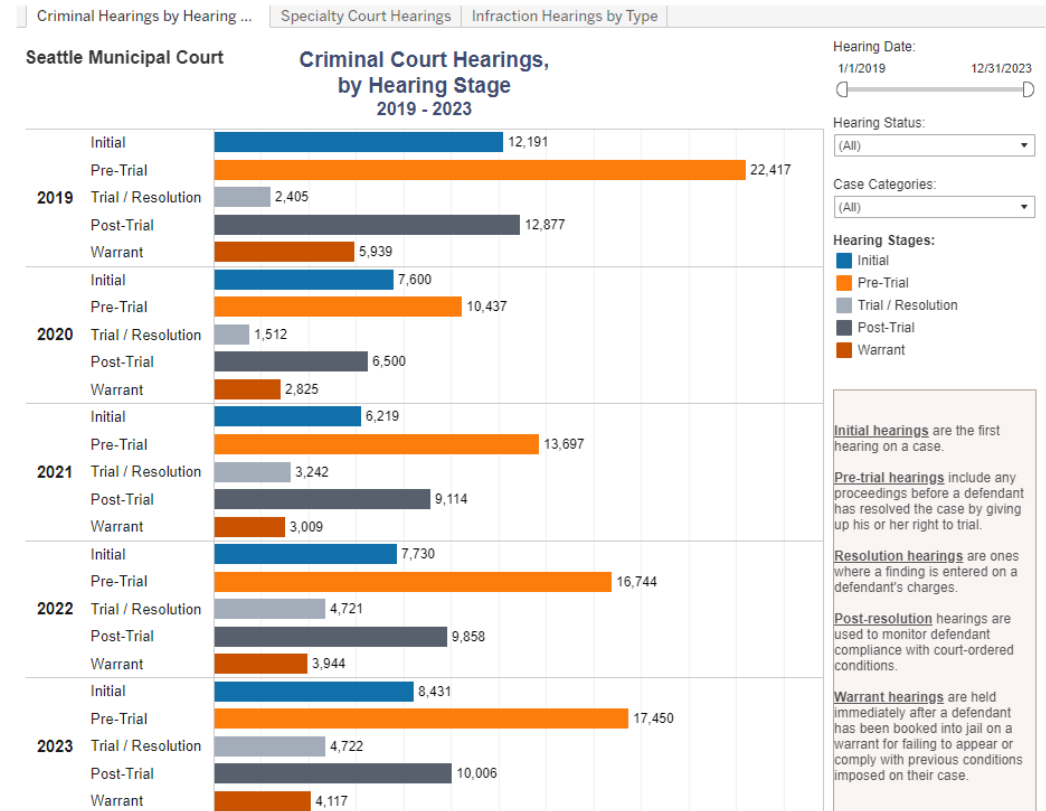
Interpreter Services: Providing access for limited English proficiency, deaf and hearing-impaired individuals.

Community Outreach: Bringing court services and programs into neighborhood centers to eliminate barriers and foster community partnerships.

Data & Performance

SMC publishes several data visualizations on frequently requested data sets including criminal case filings, hearing volume, vehicle infractions, top criminal charges, probation, therapeutic courts, electronic home monitoring utilization, and more.

2023 Accomplishments

Probation Evolution Project Concluded: SMC intentionally moved away from traditional reactive approaches to misdemeanor supervision, toward an approach that is more hopeful, equitable, and supportive of client success and growth.

MCIS 2.0 Technology Replacement: User acceptance testing, end-to-end testing and extensive staff training to prepare for go-live in Q1 2024.

Reorganization: A strategic reorganization into four service areas was finalized.

Equity and Engagement: Appointed first Director of Equity and Engagement and rolled out a new court logo and branding with RSJ Change team that better reflects the court, informed by staff and community input.

Awards: Innovating Justice Award for Probation Evolution, Asian Bar Association of Washington Judge of the Year (Judge Andrea Chin), Seattle Management Association RSJ award (Maliaka White).

New Leaders: Presiding Judge Faye R. Chess, Assistant Presiding Judge Andrea Chin, Court Administrator Josh Sattler, Judge Pooja Vaddadi, Magistrate Noah Weil.

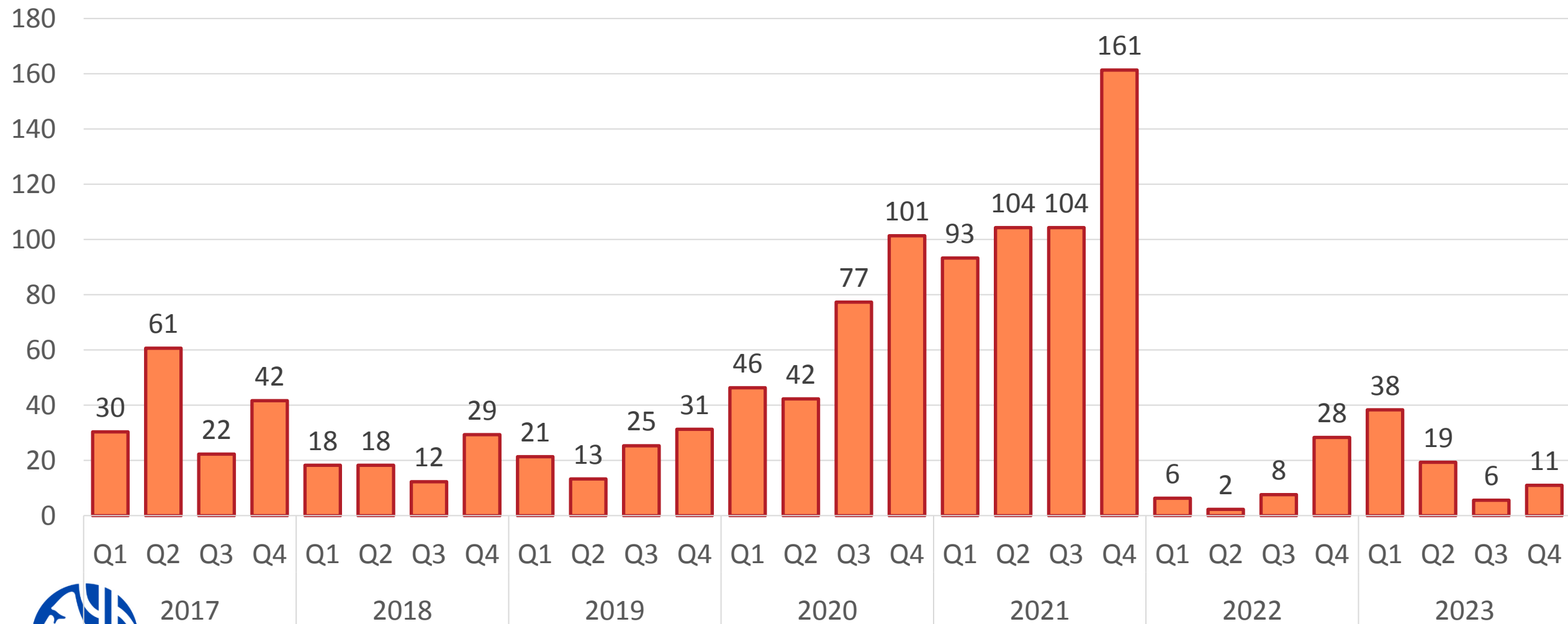


~80% of crime in Seattle is misdemeanor crime:

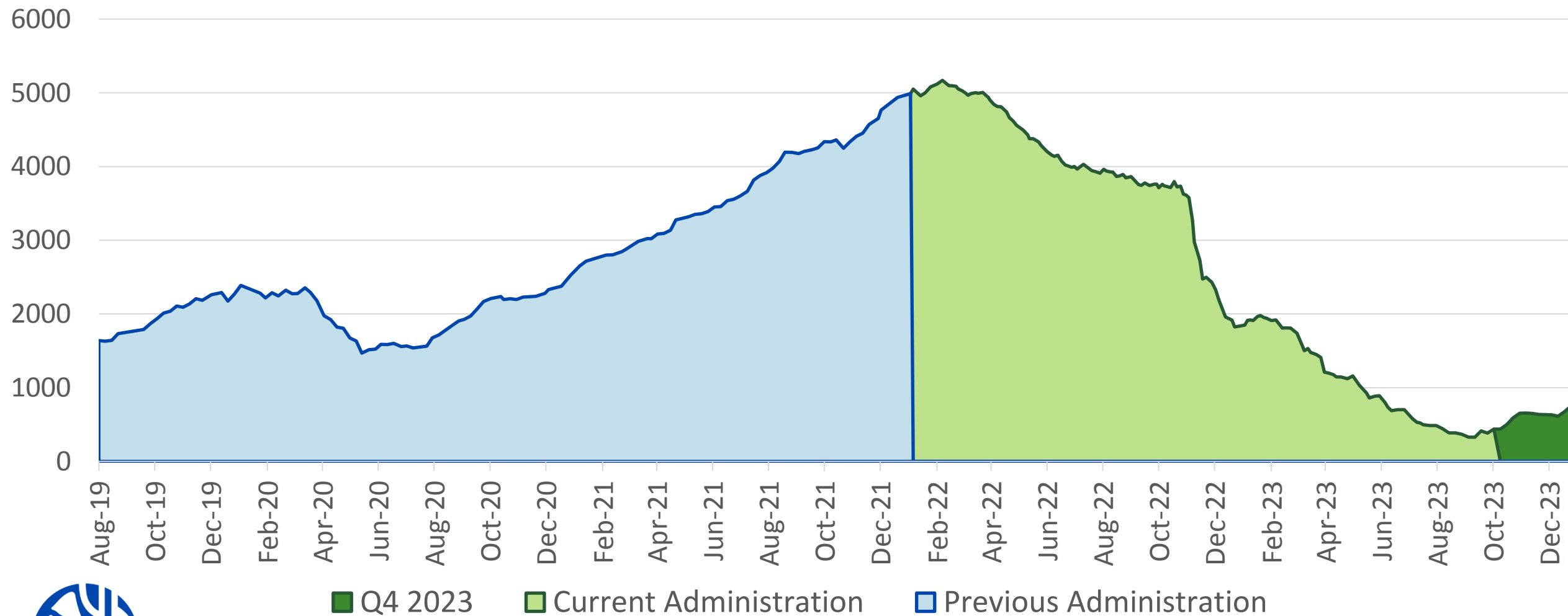
- Assault

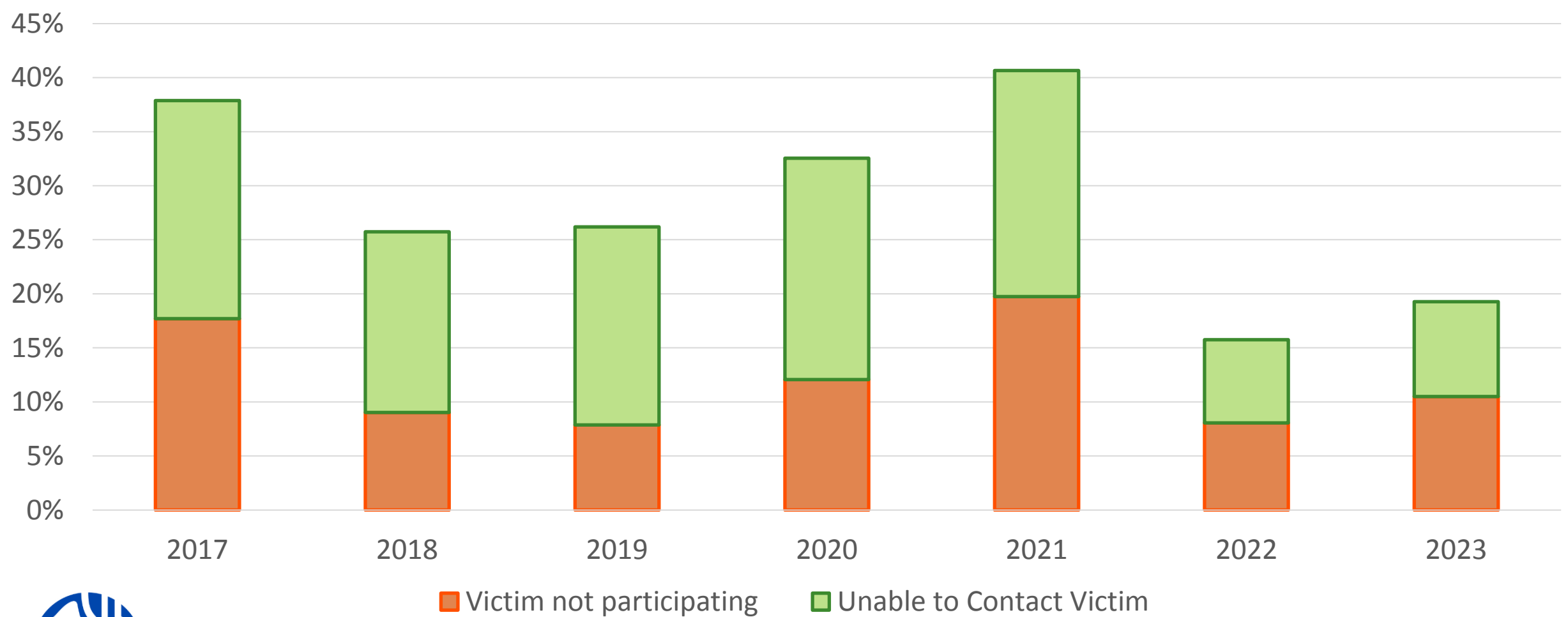
Median Time to Make a Filing Decision



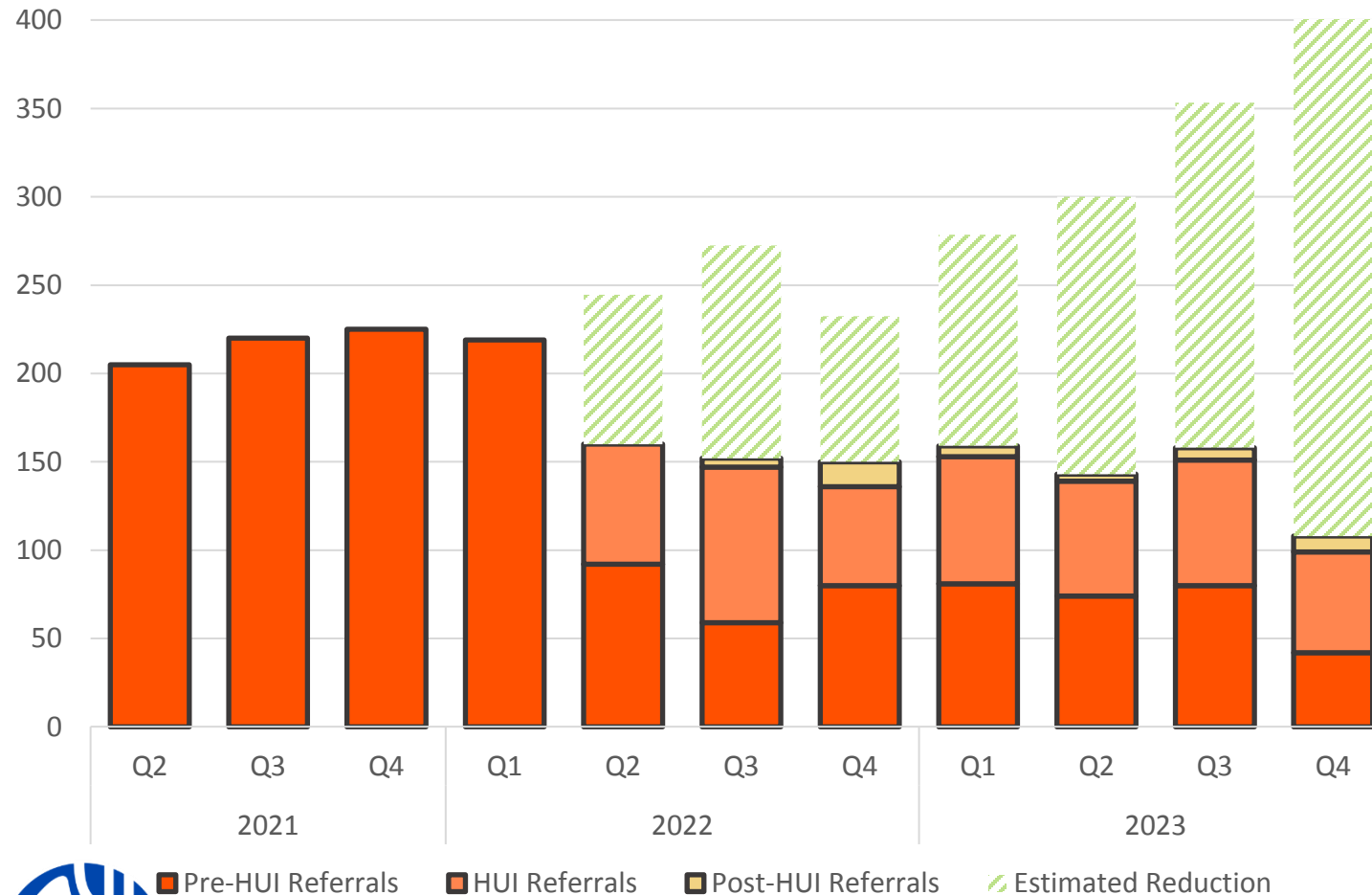
Backlog of Cases Awaiting Review

Human Trafficking

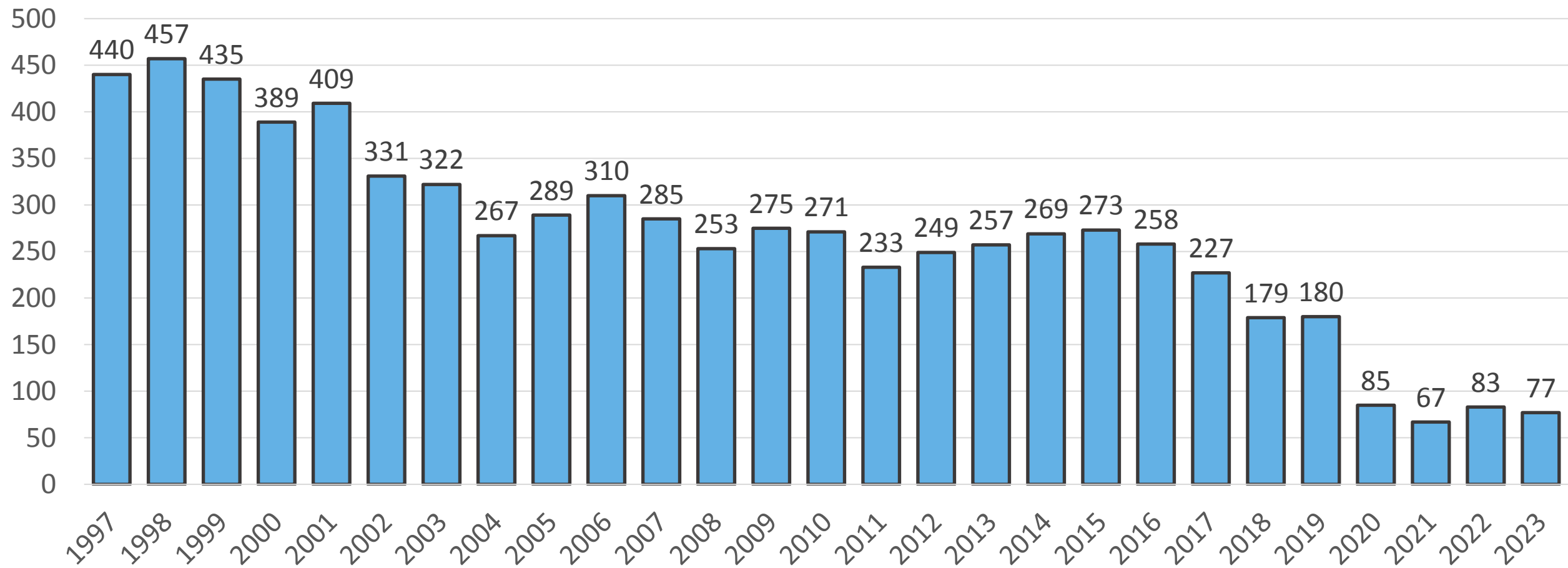
- Prostitution on Aurora
