The weekly report may be combined with information provided in the weekly reports requested in Resolution 31937.

The weekly report may be combined with information provided in the weekly reports

requested in Resolution 31937.

- Rent assistance for small businesses or individuals
- Operating assistance to cultural and non profit organizations
- Emergency housing and homelessness supports

E. Individuals enrolled in City assistance programs, such as Fresh Bucks and the Utility Discount Program.

Att 1 – Action 3 of Resolution 31940

Section 1. The Seattle City Council calls on Governor Inslee:

A. To use emergency powers to impose an immediate moratorium on residential and commercial rent payments, <u>including associated residential rental costs</u>, <u>such as renters'</u> <u>insurance</u>, such that no Seattleite should be required to pay rent during this health emergency or accumulate debt for unpaid rent; and

B. To call on federal legislators and President Trump's administration to impose an immediate moratorium on residential and commercial mortgage payments, including associated residential ownership costs, such as property taxes and mortgage insurance, such that no owner of Seattle property should be required to pay mortgage during this health emergency or accumulate additional debt for unpaid mortgage payments.

Section 2. The Seattle City Council calls on members of the United States Congress, specifically Representatives Pramila Jayapal, Adam Smith, and Financial Services Committee Chair Maxine Waters, and Senators Patty Murray and Maria Cantwell, to impose an immediate moratorium on residential and commercial mortgage payments and rents, including associated residential real property rental and ownership costs, such as property tax, renters' insurance, and mortgage insurance, such that no owner of property in the nation should be required to pay mortgage during this health emergency or accumulate additional debt for unpaid mortgage payments, and no renter in the nation should be required to pay rent during this health emergency or accumulate debt for unpaid rent.

Section 3. The Seattle City Council calls on President Trump to issue an executive order to impose an immediate moratorium on residential and commercial mortgage payments and rents, <u>including associated residential real property rental and ownership costs</u>, such as property <u>tax</u>, renters insurance, and mortgage insurance, such that no owner of property in the nation

should be required to pay mortgage during this health emergency or accumulate additional debt for unpaid mortgage payments, and no renter in the nation should be required to pay rent during this health emergency or accumulate debt for unpaid rent.

#### **CITY OF SEATTLE**

#### RESOLUTION

A RESOLUTION establishing a committee to develop recommendations to enhance the capacity of the Office of City Auditor to conduct performance audits.WHEREAS, in 1991 the voters of Seattle amended the City Charter to provide for an independent City Auditor;

and

- WHEREAS, the City Auditor has the power to direct auditing activities, including performance audits, related financial reporting and analysis, and other initiatives to improve city operations, pursuant to Chapter
   3.40 of the Seattle Municipal Code; and
- WHEREAS, Resolution 31030, adopted on January 22, 2008, recognized the City Auditor's overall priorities in developing a work program, identified a process to be implemented by the City Auditor for selection of projects to be included in a work program, authorized the City Auditor to make the final decisions regarding the content of the work program, and affirmed that the City Council will determine whether additional resources are needed to expand the Office of City Auditor's work program; and
- WHEREAS, performance audits improve the performance of operations, reduce costs, facilitate decision making, and contribute to public accountability; and
- WHEREAS, the Office of the City Auditor requires each Auditor-in-Charge to complete a work paper when initiating a new audit or non-audit project, identifying race and social justice considerations including potential disparate racial/ethnic impacts and potential benefits or issues associated with the audit; and
- WHEREAS, the Office of City Auditor's performance audits are usually initiated in response to requests from City Council and address specific performance issues; and

WHEREAS, the City Council wishes to increase the accountability, efficiency, and efficacy of City government; and

WHEREAS, the City Council desires to establish a working group to review and recommend opportunities for enhancing the capacity of the Office of City Auditor to perform performance audits; NOW, THEREFORE,

#### BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SEATTLE THAT:

Section 1. There is established a Working Group for Performance Auditing ("Working Group") to advise the Council on matters relating to an enhanced performance audit function within the Office of City Auditor. The Working Group's role shall be limited to developing recommendations for consideration by the Council, and the Working Group shall not have any independent decision-making authority.

A. The Working Group for Performance Auditing shall consist of nine voting members including the Chair of the Governance and Education Committee or designee, who shall serve as the Chair of the Working Group, and eight members appointed by the City Council, comprised as follows:

1. Two individuals with direct experience conducting performance audits of local government;

2. One individual from a company that provides performance audit, financial management,

and/or government performance analytics services;

3. One representative of a labor union;

4. One faculty member from an institution of higher education with expertise in government performance analytics;

5. One Seattle community leader with experience promoting good government practices; and

- 6. The Inspector General for Public Safety or designee; and
- 7. The City Auditor or designee.

B. The Working Group shall adopt such rules and administrative procedures for its own governance, consistent with City Charter and ordinances, as are necessary for its functions and responsibilities.

1. The Working Group shall convene at least once per month, with more meetings as needed and scheduled by the chairperson in alignment with the reporting timeline in subsection 2.B of this resolution.

2. All final documents and reports to the Council shall be posted by the Office of City Auditor to the City's website.

C. The office of the Working Group Chair shall be responsible for meeting logistics and Working Group communications and Central Staff shall prepare briefings and reports for the Working Group, in coordination with the Office of City Auditor.

Section 2. The Working Group shall perform the following duties:

A. Review and consider opportunities and challenges associated with performance audits conducted by the Office of City Auditor, including but not limited to:

1. The benefits realized from performance audits in terms of improved efficiency, effectiveness, equity, increased revenue and savings, and innovation;

2. How to maximize the benefits of using consultants in performance audits

3. Best practices of comparable local government performance audit programs, including authority, audit topic selection, staff composition and expertise, inclusion of race and social justice issues, regional partnerships, and funding; and

4. The capacity of and the required resources for the Office of City Auditor to deliver high impact analyses across City operations.

B. Report to the City Council by July 31, 2020 recommendations to strengthen the performance audit function of the Office of City Auditor.

#### **1. BILL SUMMARY**

**Legislation Title:** A RESOLUTION establishing a committee to develop recommendations to enhance the capacity of the Office of City Auditor to conduct performance audits.

**Summary and background of the Legislation:** This resolution would create a Working Group for Performance Auditing ("Working Group") charged with making recommendations to the City Council by July 31, 2020 on enhancing the capacity of the Office of City Auditor to conduct performance audits. The Working Group would consist of nine voting members, including the Chair of the Governance and Education Committee or designee who shall serve as the Chair of the Working Group, and eight members appointed by the City Council, comprised as follows:

- Two individuals with direct experience conducting performance audits of local government;
- One individual from a company that provides performance audit, financial management, and/or government performance analytics services;
- One representative of a labor union;
- One faculty member from an institution of higher education with expertise in government performance analytics;
- One Seattle community leader with experience promoting good government practices;
- The Inspector General for Public Safety or designee; and
- The City Auditor or designee.

The Working Group would consider the opportunities and challenges associated with performance audits conducted by the Office of City Auditor, including but not limited to:

- The benefits realized from performance audits in terms of improved efficiency, effectiveness, equity, increased revenue and savings, and innovation;
- How to maximize the benefits of using consultants in performance audits
- Best practices of comparable local government performance audit programs, including authority, audit topic selection, staff composition and expertise, inclusion of race and social justice issues, regional partnerships, and funding; and

• The capacity of and the required resources for the Office of City Auditor to deliver high impact analyses across City operations.

The Working Group would adopt rules and procedures. In coordination with the Office of City Auditor, the office of the Working Group Chair would be responsible for meeting logistics and communications and Central Staff would prepare briefings and reports for the Working Group.

While the proposed resolution does not have direct impact on vulnerable or historically disadvantaged communities, it is conceivable that recommendations for efficiencies or cost effectiveness from a given performance audit could have disproportionate impacts on a vulnerable or disadvantaged community. The proposed resolution notes in its recitals that the Office of City Auditor currently addresses this possibility by requiring each Auditor-in-Charge to complete a work paper when initiating a new audit or non-audit project, identifying race and social justice considerations including potential disparate racial/ethnic impacts and potential benefits or issues associated with the audit. The proposed resolution requires the work group to consider inclusion of race and social justice issues when looking for local government best practices for performance audit programs. The proposed resolution does not specify a Language Access Plan, but final documents and reports to the Council will be posted on the City's website and translation service requests can be made through the City Council customer support team at 206-684-8888.
