Small Business Stabilization Fund

- The expanded Small Business Stabilization Fund is an emergency fund that provides working capital grants in amounts up to \$10,000 to qualifying small businesses impacted by COVID-19.
- The Small Business Stabilization Fund is funded by federal Community Development Block Grants (CDBG), initially with \$2.5 million and the Mayor has proposed adding another \$1.5 million.
- The Mayor directed OED to focus outreach on historically underserved small businesses to improve access to the program for those who may be overlooked by the federal government's Small Business Administration (SBA) disaster relief program.
- Additionally, the Mayor directed OED to use a weighted lottery process to ensure that grants were predominantly awarded to businesses in high displacement risk areas.
- OED's focused outreach and the weighted lottery process resulted in nearly 80% of grant recipients identifying as business owners of color.








Small Business Stabilization Fund

- Nearly 9,000 businesses applied; nearly 6,000 of which were eligible. 252 businesses were awarded \$10,000.
- Outreach was conducted in collaboration with our neighborhood district partners. Traditional, ethnic and social media platforms were utilized. Regular updates were posted to the website and through our weekly webinars.
- OED triage team reported over 100 stabilization fund specific emails and phone calls per day.





Businesses Awarded the Stabilization Fund

"Villa Escondida is a family-owned restaurant, and we are proud to support our local community and economy here in Belltown," said Jose Perez, Owner of Villa Escondida. "Our small business was hit hard when many downtown workers began to work from home. This grant from the City will help us keep our staff on payroll and will help us increase our marketing to get more takeout and delivery orders."





Businesses Awarded the Stabilization Fund



"This will allow us to pay some of our past due business expenses, while we work on a plan to reopen," --Greg Wetzel, co-owner of South Lake Union's Zheng Cafe

"Tarik Abdullah, owner of A DJ and a Cook, will likely use his \$10,000 grant to cover short-term operational costs and hire some helpers, he said. The South Seattle-based chef has been working 13-hour days to serve paying customers with a pickup model while also donating meals to hard-up community members, he said."– Seattle Times







Next Steps

- The Mayor is proposing an additional \$1.5 million be added to the Small Business Stabilization Fund, which would allow OED to provide and additional 150 \$10,000 grants.
- The City has established a separate fund to accept private donations to support employee retention for small businesses
- OED is currently developing an equitable outreach framework for future funding projects and programs
- OED is working with firm to develop application/data management system



Our Impact

Within two years of graduating the BBC:

- **People move out of poverty:** 40% of entrepreneurs exit public assistance and 75% move out of poverty.
- **Businesses survive:** 80% of businesses are still in operation and business revenue increases by 28%, or \$550 per month.
- Businesses create jobs in their community: 46% of businesses have at least one paid employee. In Washington, 73.7% of small business owners have zero employees.



Micro- Small Businesses

Ventures focuses on micro small businesses with 1 to 5 employees, generating \$50K to \$500K in revenue

- They are the most vulnerable— facing store closures, going out of business and even homelessness.
- **The need** distribute funds with urgency and efficiency to those lacking liquidity and facing financial crisis.
- **Proposed Solution** money, strategy, technical assistance (TA), couching, access to markets and a network of people impacting the community.

Questions From Seattle City Council

How are the federal programs working for micro businesses and small businesses? What are the challenges to programs?

Federal programs are not working for micro small businesses, they were left out of the process and only the businesses that are more advanced and sophisticated with a controller, CPA or CFO were able to access the funding.

The challenges

- Confusion—lack of communication.
- Not enough funding
- Commercial banks were not prepared to support the process.
- No plan for Technical Assistance to navigate the system
- Lack of DEI in the distribution.
- Who really needs the funds?—Harvard and Ruth's Chris examples
- NOTE: Ventures' experience and other small businesses receiving PPP were successful because they worked with smaller banks and/or credit unions.



Questions From Seattle City Council

What are the major issues for micro businesses and small businesses during this time and possible challenges over the next 6 months (or 12 months)?

Access to financial resources

- Creative capital— a combination of grants and emergency loans with low or no interest. Small business need financial support to be able to recover from this crisis.
- Reduce or eliminate costs for business licenses, permits, and taxes (for a limited time).
- Access to TA ongoing support that helps businesses get back to normal.
- Business coaching and mentorship to help the business owners create a strategy to recover, pivoting the business model, embrace the crisis with a mind of opportunity. Small business owners are entrepreneurial and some will figure things out on their own, but think about the ones that don't have access to economic opportunities.



Questions From Seattle City Council

What issues are arising for small business employees? What are the challenges in our current system to assist small business employees?

- Ventures' clients have been severely impacted by social distance mandates caused by the COVID-19 crisis.
 Our business owners have seen major drops in revenue as much as 100% for some because their sales relied on in-person events (i.e. farmer's markets) or foot traffic-related sales.
- Some of our clients have lost their jobs while also experiencing reduced business sales, putting them in severe financial crisis.
- It is very complex to navigate the multiple resources that are available when you are overwhelmed.





New UI Claims March 1 – April 18 Total: 201,450




Sector and Occupation Impact


Sectors Impacted New UI Claims Jan - April 18 2020 (sectors with 5,000+)








COVID-19 MAY HIT WOMEN- AND MINORITY-OWNED BUSINESSES

Recovery: Multi-Sector Comprehensive Coordinated Response

Short Term Priorities

- > Identify and address systemic barriers to accessing economic, health and social supports
- Address immediate economic challenges
 - Improve access to resources and support (language, technology, navigation)
 - Strengthen the safety net: health care, food and economic supports
- Advocate for worker safety essential jobs and as workers start returning to work
- > Advocated for and leverage local, state, federal and private funding to address community priorities and gaps
- > Develop resources to support immigrants, gig workers and other populations that are not eligible for current supports

Near and Mid Term Recovery

- > Targeted economic assistance and support for populations and businesses most vulnerable
- Prepare workers and businesses for long term success recovering from COVID disaster skills training, subsidized wages and supports to encourage reemployment
- Focus on long-term job quality and economic inclusion
- The economic policy response to COVID-19 should be intended to maximize the share of workers who return to work, reduce duration of unemployment and improve economic stability.



Overall Reimbursement Strategy

- 1. Pursue FEMA Reimbursement where possible
- Allocate restricted CARES Act Funding (CDBG, ESG, HOPWA, Older Americans Act, Medicaid Title XIX)
- 3. Determine eligibility for \$131.5M Coronavirus Relief Fund and strategic use of funds
- 4. Utilize the \$13M Emergency Housing Grant (State Dept. of Commerce) for broader flexible funding

Allocation Strategy for Legislation

- HOPWA/Older Americans Act/Medicaid Title XIX funds
 - Restrictive funding and can leverage existing programs in HSD.
- ESG and CDBG funds
 - More flexible and amended uses were done through the CARES Act.

• ESG and CDBG strategy

- Identified areas of eligibility that had the fewest alternatives for funding and community need. Based on our assessment and current experience those gaps are:
 - Rental Assistance (CDBG/ESG)
 - Small Business Support (CDBG)
 - Food Delivery (ESG)



Housing Opportunities for People with AIDS (HOPWA): \$425k

Provide funding to HSD contracts to provide the following:

Housing Options

• Housing options for low-income persons diagnosed with HIV/AIDS requiring assistance to maintain or acquire appropriate affordable permanent housing.

• Program Services

 Short term rent, mortgage, and utility assistance, permanent housing placement, and rental assistance. Programs also include housing case management and are designed to increase participants' capability to maintain housing and to facilitate progress toward stable, long-term self-sufficient living.



Older Americans Act (\$5M) and Medicaid Title XIX (\$150k)

Human Services Department Aging and Disability Services (ADS) division is the Area Agency on Aging for King County. The following strategies provide:

• \$5M Older Americans Act:

• HSD to expand existing food delivery programs and a shift in program model from senior congregate meals to home delivery to facilitate appropriate social distancing for this population at higher risk for serious impacts from COVID-19.

• \$150K Medicaid Title XIX:

 HSD to add capacity for expedited Medicaid Long Term Services and Supports (LTSS) initial assessments, which assist with hospital patients' transitions to another care setting. In addition, funding will provide for care transitions services to non-Medicaid eligible individuals and ongoing community-based support.



Emergency Solutions Grant (ESG): \$2.8M

• \$750,000 Rental Assistance Pilot

 Provides an alternative funding source for a 2020 Council add to prevent homelessness for individuals transferring from Essential Needs or Aged, Blind, and Disable assistance programs into SSI or SSDI. Due to the General Fund revenue forecast revision, provides a more reliable funding mechanism.

• \$2,080,000 Shelter Meals

• Support the provision of meals at shelters which have had to modify operations to implement social distancing guidelines provided by Public Health Seattle/King County as a result of COVID-19.



Community Development Block Grant (CDBG): \$5.64M

• \$1.5M for HSD's Homelessness Prevention Programs

• Screen clients for risk of homelessness and assist households to maintain housing avoiding homelessness.

• \$1.5M to HSD for United Way's HomeBase rental assistance

• Provide rental assistance for households at risk of eviction and/or homelessness.

• \$1.14M to the Office of Housing's Building Stability Fund

• Provide rental assistance to non-profit building owners already in the OH portfolio. These agencies operate under rent caps, but do not have operating subsidies. They are dependent on rent payments to sustain basic building operations. Rent assistance would benefit low income tenants (<60% of AMI) and stabilize non-profit buildings and agencies.

• \$1.5M to the Office of Economic Development's Small Business Stabilization Fund

 Supports Seattle's smallest businesses facing severe financial challenges with payroll, rent, and lost revenue during the COVID-19 pandemic crisis.



Community Development Block Grant (CDBG): \$5.64M

The CARES Act waives the public services cap for 2019 and 2020 CDBG

• Rental Assistance:

- CDBG is currently capped at three months support
- Must be provided to the landlord (cannot go to individuals)

• Small Business Support:

- The "Urgent Need" National Objective allows OED to process applications more quickly; it is capped at 30% 3-year cumulative total, est. \$7-\$8M.
- This legislation would put the total at \$4m



Next Allocation of CDBG and ESG

 Second Allocation - The City anticipates receiving a second allocation of the Federal CDBG and ESG funding from the CARES Act soon.

 New Formula - The formula for the 2nd allocation is different and will be based on COVID-19 prevalence factors, among others; amounts are TBD.
