

- WHEREAS, disability communities are culturally diverse and have a long tradition of political activism, including a rich discourse around self-identification; and
- WHEREAS, some, but not all, members of disability communities use person-first language ("people with disabilities") to emphasize personhood over disability status; and
- WHEREAS, disability communities, including some members of the Deaf and Autistic communities, as well as those who proudly embrace disability as a political and/or cultural identity, have long expressed that person-first language does not represent them, preferring identity-first language ("disabled person"); and
- WHEREAS, "disability" is an umbrella term that is inclusive of the myriad disability communities who prefer person-first and identity-first language; and
- WHEREAS, the diverse body of the Seattle Commission for People with Disabilities voted unanimously on June 18, 2020 to change its name to "The Seattle Disability Commission"; and
- WHEREAS, the City of Seattle seeks to be an open and inclusive city for all its residents; NOW, THEREFORE,

Within disability communities there is a diversity of cultures, histories, and political movements. The language used for self-identification is one area in which these distinctions are readily apparent across disability communities. Many members of these communities prefer person first language while many others prefer identity first language. Changing the Commission's name to Seattle Disability Commission will create a more inclusive environment to all members of Seattle's disability communities regardless of individual language preferences.

The Commission's current name—Seattle Commission for People with Disabilities—is a person first construction. Person first language aims to center personhood over an individual's disability status. Advocates of person first language argue that its use is more humanizing and puts the focus on the whole person rather than a single characteristic.

Alternatively, identity first language puts one's disability front and center. If the Commission were to adopt identity first language, it might be called the Seattle Disabled People's Commission. For some disability communities the use of identity first language is culturally significant. For example, Deaf and Autistic communities, have long expressed a strong preference for identity first language. Additionally, many individuals from various disability communities use identity first language to reclaim disability as a political identity, similar to LGBTQ communities' reclamation of queer.

With the goal of creating greater inclusivity, Commission members deliberated and unanimously agreed that the Commission's name should be changed to Seattle Disability Commission. This is not the first time a commission has changed its name for this purpose. Most recently, the Lesbian, Gay, Bisexual, Transgender, Queer (LGBTQ) Commission added queer to its name.
