

# Funding / Origins

## Rapid Response Fund

- 2020 budget to engage community and rapidly respond to emergent threats facing Seattle immigrants
  - \$375,000 for education and assistance with public charge, DACA, and other issues (CM González)
  - \$50,000 for DACA fee assistance (CM Pacheco) + \$25,000 match from Facebook

# Joint COVID-19 Relief Package


- \$9 million from Ordinance 126211 ("Jump Start" COVID-19 relief)
  - \$8.3 million for direct cash assistance to pandemic-impacted immigrants not eligible for federal relief or state unemployment funds (Seattle COVID-19 Disaster Relief Fund for Immigrants or "SDFR")
  - \$700,000 to support ongoing Language Access in the City's COVID-19 response, including outreach for the SDRF and other services funded from 126211



# DACA: Hopeful Data from Clinics

Findings on potential eligibility:

- 30 DACA, Initial (29.7%)
- 30 DACA, Renewal (29.7%)
- 39 Family Based Petitions (38.6%)
- 5 VAWA Relief (5%)
- 24 U Visa (23.8%)
- 3 T Visa (3%)
- 4 Affirmative Asylum (4%)
- 13 Removal Defense Options (12.9%)
- 2 Advanced Parole (2%)
- 20 No relief available at this time (19.8%)



# Immigration Fee Increases



# \$150,000 Immigration Fees Scholarship Fund

- \$134,375 in fee scholarships awarded to date, including:
  - 189 DACA fee scholarships (\$93,555)
  - 36 Naturalization fee scholarships (\$26,010)
  - 7 Green Card related scholarships (\$7,890)

# Seattle COVID-19 Disaster Relief Fund for Immigrants



# Intent: to provide disaster relief to Seattle's most vulnerable low-income immigrant and refugee residents

# Eligibility Criteria

- 18 years old or older AND
- Live in/attend school in/work within the Seattle city boundaries AND
- Ineligible for federal CARES Act Economic Impact Payment ("stimulus check") due to immigration status AND
- Under 50% of the median household income in Seattle in the past 9 months

- Design informed by community feedback through two stakeholder roundtables.
- Scholarship Junkies administered the program.
- 21 partners conducted outreach and provided inlanguage application assistance.
- Application and collaterals translated into 7 languages.
- Safeguards to prevent misuse and fraud, while also protecting privacy and trust of the applicants.
- Most applicants approved for funding received assistance within two months of applying.



# The need was great.



- 18,037 applications received.
- 3,705 (20,5%) applicants received cash assistance.
- \$7,964,000 was disbursed via check, direct deposit, or giftcards.
  - o 89.53% were Seattle residents.
  - o 10.47% were applicants who worked in/went to school in Seattle.
- 61% households and 39% individuals.
- 9936 people benefited in total.
  - o 3754 were children.

- 3. Black/African American 3.64% (Amharic, Tigrinya, Somali, Oromo, Congolese, Oromifa, Garifuna)
- 4. Native American or Alaskan Native, Indigenous to Central America or South America 1.54% (K'iche)
- 5. White 1.40% (Russian)
- 6. Multiracial 0.84%
- 7. Middle Eastern or North African 0.46% (Arabic, Pashto, Dari, Farsi)
- 8. Native Hawaiian or Pacific Islander 0.27%

# What We Heard

"The stories of the people who had called made us realize how much the community needed these funds. A caller told us about how his wife had gotten COVID-19 and she ended up getting a stroke and became paralyzed from the neck down. This led him to stay home and take care of his wife, and it caused him to lose his job. It was very touching, and you could hear the anguish in his voice and that he really need the funds. We wish we could have done more."

# Seattle Values in Action!



- Collaborations were essential.
  - o City departments expedited internal processes.
  - Outreach partners/allies prioritized SDRF 17% of applications were submitted by partners on behalf of applicants.
- Language access reduced barriers to access.
  - Outreach partners helped bridge the digital divide, reached communities who had not engaged with City of Seattle programs before.
  - Majority of applications were completed inlanguage.

# Language Access Opportunities

- Strengthen relationships between city, county, and state governments.
  - Embedded OIRA's External Affairs Team in Public Health Seattle & King County and hosted webinars in 7 languages.
  - OIRA continues to liaise between Public Health Seattle & King County, Department of Health, and the City of Seattle.
- Leverage City staff's language capacity.
  - Helped the Office of Economic Development established a multilingual resource team to staff their voicemail system for their helpline: (206) 684-8090.



# Language Access Opportunities

- Build capacity in the community and respond to community needs promptly.
  - Built a COVID-19 Community Translator Team with 50+ local translators.
  - Can translate into Seattle's top 20 languages with a quick turnaround time.
- Sustain a centralized language access system.
  - Add more team capacity and introduce technical tools to support the workflow.
  - Elevate OIRA's team to become the in-house translation shop to directly provide services to other City departments.

# Centering community to achieve vaccine equity

### Community concerns voiced at our vaccine roundtables:

- The current vaccine distribution is inadequate and inequitable for BIPOC communities, as immigrant and refugee elders are struggling with getting access to appointments.
- Our community health clinics and community organizations need to be supported and positioned to reach the most vulnerable.
- Digital barriers present challenges in accessing information and signing up for appointments.
- A need for a centralized waitlist.
- In-language support is minimal, and language access must be a priority.
- WA State Department of Health phone lines need to be staffed up.





# Home Visiting

### **Nurse Family Partnership**

- Serving low-income women pregnant with first child
- Focus on improving:
  - Pregnancy outcomes
  - Child health and development
  - Economic self-sufficiency
- New mothers are partnered with a nurse for ongoing home visits pregnancy through age 2

### Investment

- \$2,350,585 General Fund
- 450 families served annually (63% BIPOC)

- 85% of graduating participants further career/education goals
- 90% of participants have positive birth outcomes

### ParentChild+ Core Model

- Research-based home visiting program focused on increasing language and literacy skills, enhancing social-emotional development, and strengthening parent-child relationships
- Culturally responsive approach implemented by Seattle CBOs
- Families receive 23 visits per year

#### Investment

- \$1.1 million annually (GF)
- 481 Seattle families served (251 funded by DEEL)

- 92% visitor cultural match for homes served: Black/African American (63%), Latinx (18%), and Asian (12%)
- Met 85% performance target growth for parent-child interaction assessment

### ParentChild+ FCC Model

- Adapted from CORE model with professional development and enrichment to FCCs
- Seattle is one of the first cities to pilot this model
- Public–private regional investment
- Two-year model with 24 weeks of programming

#### Investment

- \$ 147,000 annually (SBT)
- 16 FCCs served in 2020, 75% with less than 5 years in business

- Increases family engagement
- Parents report more reading at home and less screen time
- Facilitates connection with the PD system at-large

### **Developmental Bridge**

- Pilot program identified as a need by King County Development Screening and Analysis report in 2018-19
- Short-term support for children who are identified late, between systems, or missing qualification for ESIT
- High program demand in 2020 due to COVID-19

### Investment

- \$498,000 in 2020 (SBT)
- 120 families served (target 75)

- 92% of families feel well supported by program
- 2020 qualitative family surveys identified Bridge as critical transitional program

### **Early Learning Health**

- PHSKC Child Care Health Program (CCHP): multi-disciplinary team of public health nurses, mental health consultants, community health workers, and nutritionist
- Served critical role in COVID-19 response effort with weekly Zoom TA sessions for CCAP providers and City staff

### Investment

- \$874,000 in 2020 (SBT)
- Serves ~200 CCAP providers

### Results

 More than 500 infant and toddler visits during 2020



# B-3 Coaching and Professional Development

- Culturally-responsive coaching and professional development for CCAP providers serving infants and toddlers.
  - In-classroom coaching for B-3 settings
  - B-3 training series and professional learning communities
- Pilot started in 2019, pivoted to virtual services in 2020

### **Investment**

- \$720,000 in 2021
- Serves ~130 CCAP providers serving infants and toddlers

- 32 classrooms/FCCs in first cohort of coaching in 2019 (60 teachers and 320 children)
- 344 educators attending training series



# **PN-3 Community Grant Program**

- New \$1.5 million of 2021 Sweetened Beverage Tax funds to implement a Prenatal-to-Three Community Grant Program
- Planning through Spring 2021, RFP expected in summer.
- Fund community-based and community-designed programs that supports young families.

# 2020 Expansion Plan

### Implemented:

- Eligibility increased from 300% to 350% FPL
- Simplified and streamlined application process
- Provider participation incentives

#### **Interrupted:**

 New quality support model with professional development

# **Child Care Stabilization Fund**



### **Child Care Stabilzation Grants**

- \$2.4M in grant funds
- Licensed and school-age providers
- Separate process for family, friend and neighbor caregivers
- Prioritize providers serving children on subsidy and in priority geographic areas

### Child Care Stabilization Fund

- \$2.3 million and 506 grants awarded
- Child Care Resources partnership

344




# **CCAP Utilization**

- In 2020, overall enrollment dropped 30%
- Prior annual increase of 19%-21%






# 2020 CCAP Enrollment

- Infant enrollments decreased 72%
- School Age enrollments decreased 33%
- Preschool Age enrollments decreased 27%
- Toddlers decreased 7%






# Dec 2020 CCAP Enrollment

 Infant and toddler participants are more likely to be Black/African American than other age groups






# Dec 2020 CCAP Enrollment
