Amend Section 1 of Council Bill 120157 as shown:

Section 1. Section 23.42.055 of the Seattle Municipal Code, enacted by Ordinance 126384, is amended as follows:

23.42.055 Low-income housing on property owned or controlled by a religious organization

* * *

C. Affordability requirements

1. Eligible households. All dwelling units or congregate residence sleeping rooms permitted pursuant to this Section 23.42.055 shall serve only:

a. For rental units.

1) ((households)) Households with incomes no greater than 60 percent of median income, adjusted by household size, or

2) In the Rainier Beach Urban Village, Othello Urban Village, Westwood-Highland Park Urban Village, South Park Urban Village, Bitter Lake Urban Village, Columbia City Urban Village, Lake City Urban Village, North Beacon Hill Urban Village, North Rainier Urban Village, 23rd & Jackson Urban Village, University District Urban Center, First Hill/Capitol Hill Urban Center, and Downtown Urban Center, households with incomes no greater than 80 percent of median income, adjusted by household size.

((1) In development with a complete Master Use Permit application, if required, or complete building permit application filed by July 1, 2022, households with incomes no greater than 80 percent of median income, adjusted by household size, or

2) In development with a complete Master Use Permit application, if required, or complete building permit application filed after July 1, 2022, households with incomes no greater than 80 percent of median income, adjusted by household size, and average household income across all units in the project no greater than 60 percent of median income.))

b. For ownership units, households with incomes no greater than 80 percent of median income, adjusted by household size.

- 2. Duration. The obligation to provide dwelling units meeting the requirements of subsection 23.42.055.B shall last for a period of 50 years from the date of the certificate of occupancy or, if a certificate of occupancy is not required, from the date of the final building permit inspection for the development to which this Section 23.42.055 applies.
- 3. Affordable rent. Monthly rent shall not exceed 30 percent of ((80 percent of median income)) the applicable income limit established by subsection 23.42.055.C.1. For purposes of this subsection 23.44.055.C.3, "monthly rent" includes a utility allowance for heat, gas, electricity, water, sewer, and refuse collection, to the extent such items are not paid for tenants by the owner, and any recurring fees that are required as a condition of tenancy.

Amend subsections B and C and delete subsection D of proposed Seattle Municipal Code section 23.49.167 as shown on pages 2 and 3 of Council Bill 120153, as follows:

* * *

B. Lot coverage

- 1. For lots 8,000 square feet or less in size, development must meet one of the following:
- a. Portions of structures above 25 feet in height shall not exceed a lot coverage of 80 percent; or
- b. Portions of structures above 25 feet in height shall not exceed a lot coverage of 85 percent and the development does shall not exceed a height of 135 feet, excluding rooftop features and any additional height granted by the Living Building Pilot program in Section 23.40.060.
- 2. For lots greater than 8,000 square feet but and 14,500 square feet or less in size, portions of structures above 45 feet in height shall not exceed a lot coverage of 75 percent and the development shall not exceed a height of 145 feet, excluding rooftop features and any additional height granted by the Living Building Pilot program in Section 23.40.060.
 - C. Maximum width and depth

- 1. The maximum width and depth for any portion of a structure above 45 feet in height is 100 95 feet on avenues and 120 feet on east/west streets. The maximum applies to the width and depth of portions of structures as measured parallel to any street lot line.
- 2. Any portion of a structure above 45 feet in height shall be separated horizontally by at least 20 feet at all points from any other portion of a structure on the lot above 45 feet in height.
- D. Green street setbacks. If the structure is located on the northern side of the green street on a lot 8,000 square feet or less in size, portions of structures above 25 feet in height shall be set back 10 feet from the street lot line of a green street designated on Downtown Overlay Map 1B. If the structure is located on the southern side of the green street or on a lot greater than 8,000 square feet, the standards of subsection 23.49.166.B shall still apply.

Amendment 2

CB 120173 – Economic displacement relocation assistance

Sponsor: CM Sawant

Amend recitals and Section 1 of CB 120173 as shown:

- WHEREAS, rent increases may cause many households to move due to their inability to pay the higher rent; and
- WHEREAS, rents in Seattle have been increasing rapidly and vacancies in affordable rental housing are at low levels, making it increasingly difficult for many households to locate rental housing; and
- WHEREAS, before moving into a rental unit, landlords typically require that households pay some type of security deposit and other move-in fees; and
- WHEREAS, these conditions in the rental market have created a relocation crisis because many households do not have sufficient resources to save money to cover moving expenses; and
- WHEREAS, providing economic displacement relocation assistance to households who move following a rent increase of ten percent or more will help households obtain replacement housing and mitigate the impact of the rent increase on the relocation crisis; and
- WHEREAS, including an income threshold above which households cannot receive benefits will require submission of proof of income; and
- WHEREAS, this type of means testing can be a significant barrier to application even for those who are eligible for assistance; and
- WHEREAS, the amount of average rent in Seattle is so high that even those that are not considered low income but are making the average income for a household in the city are often rent-burdened; and

WHEREAS, the Council finds that this ordinance will protect and promote the health, safety, and welfare of the general public; NOW, THEREFORE,

* * *

Section 2. A new Chapter 22.212 is added to the Seattle Municipal Code as follows:

* * *

22.212.030 Criteria for economic displacement relocation assistance

A household representative is entitled to economic displacement relocation assistance if:

- A. A tenant of the housing unit has received a required rent-increase notice;
- B. The household representative complies with the deadlines or extensions in Section 22.212.040; and
- C. After receiving the required rent-increase notice but before the rent increase takes effect, the household vacates the housing unit or a member of the household has given written notice to the owner of the date the household intends to vacate the housing unit; and
 - D. The household is a low-income household as defined in Section 23.84A.016.

22.212.040 Application for economic displacement relocation assistance

A. Within 180 days after a tenant receives a required rent-increase notice or 60 days after the rent increase goes into effect, whichever date is later, the household representative may apply to the Director for economic displacement relocation assistance by submitting an application to the Director on a form approved by the Director. If the household representative fails to submit an application within either 180 days after a tenant in the household receives the required rent-increase notice or 60 days after the rent increase goes into effect, whichever date is later, the household representative is not entitled to economic displacement relocation assistance unless the household representative requests, and the Director approves the request for, an extension of time to submit the application. The extension request must explain why the household representative is unable to apply before the expiration of the applicable period. The Director shall approve the extension request if the Director receives it before the

expiration of the applicable period and determines that the household representative has good cause for being unable to apply within the applicable period. The Director shall notify the household representative and the owner in writing whether the extension has been approved or rejected. If the Director approves the extension, the household representative will have an additional 60 days after the expiration of the original 180-day or 60-day period, whichever expires later, in which to submit the application.

B. The application shall include:

- 1. An affidavit identifying the date the household representative's household vacated the housing unit or a copy of the notice the household gave to the owner identifying the date the household intends to vacate the housing unit;
- 2. A copy of the current rental agreement or, if the tenancy is not subject to a written agreement or the household does not have a copy of it, proof of housing costs for the 12 months prior to the effective date of the required rent-increase notice or for the household's tenancy in the housing unit, whichever period is shorter;
- 3. Documentation establishing that that rent increase is for ten percent or more or, in combination with all other rent increases taking effect within 12 months prior to the effective date of that rent increase or the household's tenancy in the housing unit, whichever period is shorter, will result or resulted in a cumulative rent increase of ten percent or more; and
- 4. The number of family and non-family households occupying the housing unit and the names of all members of each household; and
- 5. For the household applying for assistance, the total combined annual income for the previous calendar year, and the total combined income for the current calendar year.



- WHEREAS, during the COVID-19 pandemic, many City employees have been required to perform essential functions and deliver critical services to the community that can only be performed in person; and
- WHEREAS, these employees play an essential role in the City and are on the front lines of delivering essential public services; and
- WHEREAS, because of COVID-19, these employees may have experienced increased hardship, such as lack of public transit, limited access to childcare, and other challenges; and
- WHEREAS, retention of these employees is of the upmost importance, and the City seeks to provide some additional acknowledgment of their extraordinary efforts; and
- WHEREAS, the City also seeks to bolster front-line employee morale so they can continue to provide these essential in-person public services through the end of the current public health emergency; and
- WHEREAS, collective bargaining has led to tentative agreements between The City of Seattle and certain City unions; and
- WHEREAS, the City Budget Office has identified General Fund reserves sufficient to cover the estimated cost resulting from agreements and will submit subsequent legislation to appropriate funds once the departmental totals and payment timing are settled; and
- WHEREAS, the City resolves to also apply such benefits to eligible employees not covered by a collective

bargaining agreement; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. As requested by the Seattle Human Resources Director and recommended by the Mayor, the Mayor is authorized on behalf of The City of Seattle (City) to execute an agreement between the City and certain City unions, substantially in the form attached to this ordinance as Attachment 1 and identified as "Agreement Coalition of City Unions and Certain Other Signatory Unions and The City of Seattle." The Mayor shall only execute this agreement with unions who have ratified it.

Section 2. As requested by the Seattle Human Resources Director and recommended by the Mayor, the Mayor is authorized on behalf of The City of Seattle (City) to execute an agreement between the City and the International Brotherhood of Fire Fighters Local 27, substantially in the form attached to this ordinance as Attachment 2 and identified as "Agreement International Association of Fire Fighters Local 27 and The City of Seattle." The Mayor shall only execute this agreement after the union has ratified it.

Section 3. As requested by the Seattle Human Resources Director and recommended by the Mayor, the Mayor is authorized on behalf of The City of Seattle (City) to execute an agreement between the City and certain City unions, substantially in the form attached to this ordinance as Attachment 3 and identified as "Memorandum of Agreement by and between The City of Seattle Municipal Court and Public, Professional & Office-Clerical Employees and Drivers Local Union No. 763" The Mayor shall only execute this agreement after the union has ratified it.

Section 4. This section shall apply to eligible City employees who are not represented by a union or covered by a collective bargaining agreement.

A. Acknowledgement of front-line worker pay. Current City of Seattle employees who have been required to perform work in person at City job sites and offices during the pandemic will be paid a one-time taxable payment of up to \$1,750 (pro-rated for part-time employees). Eligible employees must be on the City's payroll on or after August 1, 2021. Employees who separated from employment prior to August 1, 2021 are

not eligible to receive this payment. This payment will be paid to eligible employees no later than March 31, 2022 as long as the employee timely files their paperwork.

During the COVID-19 pandemic, many City employees have been required to perform essential functions and deliver critical services to the community that can only be performed in person. Because of COVID-19, these employees may have experienced increased hardship (i.e. lack of public transit, limited access to childcare, etc.). These employees play an essential role in the City and are on the front lines of delivering essential public services. Retention of these employees is of the upmost importance, and the City is providing some additional acknowledgment of their extraordinary efforts. The City also seeks to bolster their morale so they can continue to provide these essential in-person public services through the end of the current public health emergency.

The City of Seattle ("City"), Coalition of City Unions ("Coalition"), and other signatory unions ("Signatory Unions"), (collectively, "Parties"), the Parties enter into the following Agreement (Agreement).

- A. **Acknowledgement of Front-Line Worker Pay:** Current City of Seattle employees who have been required to perform work in person at City job sites and offices during the pandemic will be paid a one-time taxable payment of up to \$1,750.00 (pro-rated for part-time employees). Eligible employees must be on the City's payroll on or after August 1, 2021. Employees who separated employment prior to August 1, 2021 are not eligible to receive this payment. This payment will be paid to eligible employees no later than March 31, 2022 as long as the employee timely files their paperwork.
- B. **Employee Eligibility Self-Attestation:** To qualify for this Acknowledgement of Front-Line Worker Pay and determine lump sum amount, an employee must certify in writing each of the following:

Eligible employees may elect to continue their current telework arrangement until January 19, 2022 unless there is a business need for them to return to the worksite. While the parties understand that continued telework will be considered voluntary on the part of the employee after October 18, 2021, the Department will have the sole discretion on when to return an employee providing a legitimate business need which is clearly and succinctly described in a notice to the employee and the union.
- D. This Agreement represents the entire agreement and understanding of the Parties as to the subject of this Agreement.
- E. SEVERABILITY. If any of the provisions of this Agreement are held to be invalid or unenforceable, the remaining provisions will nevertheless continue to be valid and enforceable. 1. BILL SUMMARY

Legislation Title: AN ORDINANCE relating to City employment; authorizing the execution of agreements between The City of Seattle and certain City unions; authorizing compensation for certain City employees not covered by a collective bargaining agreement; and ratifying and confirming certain prior acts.

Summary and background of the Legislation:

This legislation authorizes three tentative agreements to provide "acknowledgement pay" to qualifying employees represented by certain City unions, and to employees not covered by a collective bargaining agreement. The City is authorized to execute any of the agreements with City unions whose membership has ratified it.

The intent of the legislation is to acknowledge hardships, offset additional costs, and retain front-line City employees who continued to deliver in-person, essential City services during the COVID-19 public health emergency. Employees shall be eligible for a one-time payment of up to \$1,750 (\$100/month), pro-rated by the number of hours and months they worked at a City worksite, retroactive to March 2020. The payment is structured so that employees cannot qualify for both the maximum acknowledgement pay and the telework reimbursement, although it is possible to receive a partial, pro-rated amount if they worked the required in-person hours.

The City Budget Office has calculated a preliminary cost estimate based on the terms in the tentative agreement and is holding reserves in the General Fund. Once an employee attestation and management review process is completed, and the timing for payments is settled, the City Budget Office will appropriate funds to departments in either 2021 or 2022.

Subject: CB 120186 – Additional Pay for Front-Line Workers

On October 11, 2021, the Council will discuss and possibly vote on <u>Council Bill (CB) 120186</u> that would authorize additional pay for eligible front-line City employees. This memo provides a high-level summary of the bill, describes a potential amendment to the bill, and identifies next steps.

Summary

CB 120186 would ratify three tentative agreements with:

- 1. The Coalition of City Unions and other signatory unions (including most but not all unions representing City staff);
- 2. The Internal Association of Fire Fighters Local 27; and
- 3. the Public, Professional & Office-Clerical Employees and Drivers Union Local No. 763 (Municipal Court).

These agreements would provide up to \$1,750 in a lump sum payment to eligible front-line City employees. CB 120186 would also authorize providing the same lump sum payment to eligible non-represented front-line employees throughout the City. The City and the Seattle Police Officers Guild have not yet reached a tentative agreement.

In transmitting the legislation for Council's consideration, the City Budget Office indicates that the intent of the legislation is "to acknowledge hardships, offset additional costs, and retain front-line City employees who continued to deliver in-person, essential City services during the COVID-19 public health emergency."

CB 120186 would authorize a lump sum payment to eligible employees of up to \$100/month, pro-rated by the number of hours and months they worked at a City worksite, retroactive to March 2020. In any given month during this period, employees could not qualify for both the maximum telework reimbursement (\$48 per month) and the additional maximum monthly payment amount authorized by CB 120186 (\$100 per month).

The City Budget Office calculates that the cost for additional pay to eligible represented and non-represented staff is approximately \$6.5 million, and there are equivalent reserves in the General Fund needed to support these costs. Future legislation will be needed in 2021 or early 2022 to authorize the necessary appropriations to make payments to eligible employees.

Potential Amendment

Council President González may be interested in moving Amendment A to CB 120186 (see Attachment 1) that would ratify another tentative agreement regarding additional pay for eligible employees. Specifically, Amendment A would ratify a tentative agreement between the City of Seattle's Legislative Department and the union representing Central Staff analysts (see Attachment 2 [labeled as "Attachment 4" (to CB 120186)]. The terms of the tentative agreement that would be added by this amendment are consistent with the material elements of the other agreements addressed in the legislation.

Next Steps

If the Council votes to approve CB 120186, the Seattle Department of Human Resources would execute the tentative agreements with the applicable unions.

The Mayor's Office expects to transmit future, separate legislation for the Council's consideration that appropriates funding needed to make the payments contemplated in CB 120186 for eligible represented and non-represented employees.

Authorize Ratifying an Agreement with Central Staff Analysts

On page 3, beginning on line 1, add the following new section (and change the other section numbers accordingly):

Section 4. As requested by the Seattle Human Resources Director, the Mayor is authorized on behalf of The City of Seattle (City) to execute an agreement between the City and certain City unions, substantially in the form attached to this ordinance as Attachment 4 and identified as "Agreement by and between PROTEC17 and the City of Seattle." The Mayor shall only execute this agreement after the union has ratified it.

Effect: This amendment would ratify another tentative agreement regarding additional pay for eligible employees. Specifically, the amendment would ratify the tentative agreement between the City of Seattle's Legislative Department and the union representing Central Staff analysts. The terms of the tentative agreement that would be added by this amendment are consistent with the material elements of the other agreements addressed in the legislation.

AGREEMENT BY AND BETWEEN PROTEC17 AND THE CITY OF SEATTLE

During the COVID-19 pandemic, many City employees have been required to perform essential functions and deliver critical services to the community that can only be performed in person. Because of COVID-19, these employees may have experienced increased hardship (i.e. lack of public transit, limited access to childcare, etc.). These employees play an essential role in the City and are on the front lines of delivering essential public services. Retention of these employees is of the upmost importance, and the City is providing some additional acknowledgment of their extraordinary efforts. The City also seeks to bolster their morale so they can continue to provide these essential in-person public services through the end of the current public health emergency.

The City of Seattle ("City") and PROTEC17 ("PROTEC17"), collectively referred to herein as "the Parties," enter into the following Agreement ("Agreement"):

- A. **ACKNOWLEDGEMENT OF FRONT-LINE WORKER PAY:** Current City of Seattle employees employed by the City's Legislative Branch, and who have been required to perform work in person at City job sites and offices during the pandemic, will be paid a one-time taxable payment of up to \$1,750.00 (pro-rated for part-time employees). Eligible employees must be on the City's payroll on August 1, 2021. Employees who are no longer employed are not eligible to receive this payment. This payment will be paid to eligible employees no later than March 31, 2022, as long as the employee timely files their paperwork.
- B. **EMPLOYEE ELIGIBILITY SELF-ATTESTATION:** To qualify for this Acknowledgement of Front-Line Worker Pay and determine lump sum amount, an employee must certify in writing each of the following:
 - 1. **Eligibility for Work Performed in Person** Employee was directed by management, or the work was required to be performed in-person, at any time between March 20, 2020, and December 31, 2021.
 - 2. **Lump Sum Calculation** An Employee may qualify for either a full monthly payment or partial monthly payment as set forth below:
 - a. **Full Monthly Payment** For each month between March 9, 2020 through December 31, 2021, if an employee was directed by management or the work was required to be performed in-person for greater than 110 regular hours in the month, the employee shall receive \$100 for that month. However, an employee

will not be eligible to receive Acknowledgement of Front-Line Worker Pay for any month in which the employee received 100% of the Telework Stipend.

Partial Monthly Payment – For any month in which an employee was directed by management to perform in-person work or where the nature of the work required it to be performed in person more than 94 regular hours but not exceeding 110 regular hours in the month, and where any such employee received 50% of the Telework stipend in that same period, that employee will receive 50% of the Acknowledgement of Frontline Worker Pay for that month.

- 3. **Total Compensation** No employee's combined payment of Telework Reimbursement and Front-Line Worker Acknowledgement Pay shall exceed a maximum of \$100 for any month. The total Front-Line Worker Acknowledgement Pay lump sum payment shall not exceed \$1,750.00.
- C. Upon Tentative Agreement of this proposal, the Council President/Council President Pro Tem will modify their March 6, 2021 directive, making employee telework voluntary effective no sooner than November 29, 2021, and notifying employees that they will still receive the allowance as set forth the City's Fixed Rate Utility Allowance Memorandum Of Understanding which expires October 18, 2021, until telework is made voluntary. Should telework be made voluntary before January 19, 2022, eligible employees may elect to continue their current telework arrangement until January 19, 2022, unless there is a business need for them to return to the worksite. While the Parties understand that continued telework may be considered voluntary on the part of the employee on or after November 29, 2021, the Department will maintain the sole discretion on whether there is a business need for the employee to return to the worksite prior to that date. Where the Department exercises such discretion, it will provide a notice to any impacted employee and the union, setting forth the clear and succinct legitimate business need for the employee's return to the workplace.
- D. This Agreement represents the entire agreement and understanding of the Parties as to the subject of this Agreement.
- E. **SEVERABILITY**. If any of the provisions of this Agreement are held to be invalid or unenforceable, the remaining provisions will nevertheless continue to be valid and enforceable. However, if the payment is deemed unlawful or if this Agreement is not ratified by the City Council, the Agreement shall be null and void and any payments previously paid must be paid back to the City. The provisions of this Agreement will not be construed against any party.
- F. **DISPUTES**. Issues arising over the interpretation, application, or enforceability of the provisions of this agreement shall be addressed during labor management meetings convened and held for all signatory unions, upon request by any Party, and shall not be subject to the grievance procedure set forth in the Parties' collective bargaining agreements.

G.	NO PRECEDENT . This Agreement does not constitute a practice or precedent and canno be used by the Parties in any matter or proceeding, except for the sole purpose of enforcing the Agreement itself. The Parties agree the acknowledgment payment described above is a one-time payment and arises out of the unique circumstances of the public health emergency.
