COUNCIL BILL	

AN ORDINANCE appropriating money to pay certain audited claims and ordering the payment thereof.

## BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$53,249,823.12 on Summit mechanical warrants numbered 4002898128 - 4002901327 plus manual or cancellation issues for claims, E-Payables of \$130,085.54 on Summit 9000029955 - 9000030024 and Electronic Financial Transactions (EFT) in the amount of \$73,978,269.58 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2. Payment of the sum of \$44,944,710.57 on City General Salary Fund mechanical warrants numbered 51286592 - 51287265 plus manual warrants, agencies warrants, and direct deposits numbered
