Payment of the sum of \$28,196,413.64 on Summit mechanical warrants numbered 4002453908 - 4002456881 plus manual or cancellation issues for claims, E- Payables of \$144,143.69 on Summit 9000019174 - 9000019238 and Electronic Financial Transactions (EFT) in the amount of \$46,796,579.17 are presented for ratification by the City Council per Chapter RCW 42.24.180.
