COUNCIL BILL					

AN ORDINANCE appropriating money to pay certain audited claims and ordering the payment thereof.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$21,158,446.48 on Summit mechanical warrants numbered 4002489808- 4002492670 plus manual or cancellation issues for claims, E-Payables of \$85,641.05 on Summit 9000020093 - 9000020173 and Electronic Financial Transactions (EFT) in the amount of \$38,080,203.60 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2. Payment of the sum of \$39,484,180.81 on City General Salary Fund mechanical warrants numbered 51228065 - 51228822 plus manual warrants, agencies warrants, and direct deposits numbered 180001 - 191809 representing Gross Payrolls for payroll ending date April 21, 2015 as detailed in the Payroll
