## BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$21,951,177.97 on Summit mechanical warrants numbered 4002495808 - 4002498415 plus manual or cancellation issues for claims, E-Payables of \$138,371.78 on Summit 9000020270 - 9000020370 and Electronic Financial Transactions (EFT) in the amount of \$17,027,210.57 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2. Payment of the sum of \$39,575,541.54 on City General Salary Fund mechanical warrants numbered 51228823 - 51229554 plus manual warrants, agencies warrants, and direct deposits numbered 200001 - 211786 representing Gross Payrolls for payroll ending date May 5, 2015 as detailed in the Payroll
