AN ORDINANCE appropriating money to pay certain audited claims and ordering the payment thereof.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$25,518,985.86 on Summit mechanical warrants numbered 4002685353 - 4002688186 plus manual or cancellation issues for claims, E-Payables of \$125,052.03 on Summit 9000024885 - 9000024961 and Electronic Financial Transactions (EFT) in the amount of \$34,061,620.12 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2. Payment of the sum of \$44,756,356.14 on City General Salary Fund mechanical warrants numbered 51255559 - 51256765 plus manual warrants, agencies warrants, and direct deposits numbered

Section 4. This ordinance shall take effect and be in force 30 days after its approval by the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it shall take effect as provided by Seattle Municipal Code Section 1.04.020.
