AN ORDINANCE appropriating money to pay certain audited claims and ordering the payment thereof.

## BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$16,845,348.81 on Summit mechanical warrants numbered 4002725257 - 4002727852 plus manual or cancellation issues for claims, E-Payables of \$118,024.54 on Summit 9000025712 - 9000025782 and Electronic Financial Transactions (EFT) in the amount of \$43,320,130.63 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2. Payment of the sum of \$43,266,028.56 on City General Salary Fund mechanical warrants numbered 51262372 - 51263157 plus manual warrants, agencies warrants, and direct deposits numbered
