ORDINANCE

COUNCIL BILL _____

AN ORDINANCE authorizing the CEO/General Manager of Seattle Public Utilities to execute an amendment to the contract with Waste Management of Washington, Inc., for waste disposal and transportation services; amending Ordinance 125207, which adopted the 2017 Budget, changing appropriations for Seattle Public Utilities; and ratifying and confirming certain prior acts.

WHEREAS, the City has a contract with Waste Management of Washington, Inc., for waste disposal and

transportation services, dated September 11, 1990, and amended on October 31, 1996, February 5, 2001,

and February 9, 2009; and

- WHEREAS, Seattle Public Utilities and Waste Management of Washington, Inc., negotiated mutually agreed terms for a fourth Amendment that will reduce City service payments and extend an interim opt-out date; and
- WHEREAS, the Council reserves the right to appropriate savings associated with reduced City service payments within the Solid Waste Fund; and
- WHEREAS, the Council requests Seattle Public Utilities (SPU) notify the Chair of the Civil Rights, Utilities, Economic Development and Arts Committee or the appropriate committee Chair, prior to a decision to either amend or bid SPU's long-haul waste disposal contract; and
- WHEREAS, the Council prefers the open public procurement process in 2021 as a means of encouraging competitive bids to the benefit of the rate payer; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY

Section 1. The CEO/General Manager of Seattle Public Utilities is authorized to execute, for and on behalf of The City of Seattle, an amendment to the contract with Waste Management of Washington, Inc., for waste disposal and transportation services, substantially in the form of the contract amendment attached to this ordinance as Attachment 1.

Section 2. Any act consistent with the authority of this ordinance taken after its passage and prior to its effective date is hereby ratified and confirmed.

Section 3. The appropriation for the following item in the 2017 Adopted Budget is reduced from the fund shown below:
