Title: AN ORDINANCE amending Ordinance 125207, which adopted the 2017 Budget, including the 2017-

2022 Capital Improvement Program (CIP) (commonly known as the 2nd quarter supplemental); changing appropriations to various departments and budget control levels, and from various funds in the Budget; adding new projects; revising project allocations for certain projects in the 2017-2022 CIP; creating both new exempt and non-exempt positions; making cash transfers between various City

funds; and ratifying and confirming certain prior acts; all by a 3/4 vote of the City Council.
