COUNCIL BILL

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$24,261,033.86 on Summit mechanical warrants numbered 4002850008 - 4002852690 plus manual or cancellation issues for claims, E-Payables of \$75,879.31 on Summit 9000028688 - 9000028756 and Electronic Financial Transactions (EFT) in the amount of \$43,344,463.21 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2. Payment of the sum of \$46,339,795.34 on City General Salary Fund mechanical warrants numbered 51278266 - 51279684 plus manual warrants, agencies warrants, and direct deposits numbered
