AN ORDINANCE appropriating money to pay certain audited claims and ordering the payment thereof.

COUNCIL BILL

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$35,159,135.88 on Summit mechanical warrants numbered 4002904444 - 4002907774 plus manual or cancellation issues for claims, E-Payables of \$165,995.45 on Summit 9000030090 - 9000030163 and Electronic Financial Transactions (EFT) in the amount of \$39,667,518.05 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2. Payment of the sum of \$44,912,944.71 on City General Salary Fund mechanical warrants numbered 51287266 - 51287965 plus manual warrants, agencies warrants, and direct deposits numbered
