COUNCIL BILL

AN ORDINANCE appropriating money to pay certain audited claims and ordering the payment thereof.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$25,422,919.61 on PeopleSoft 9.2 mechanical warrants numbered 4100082820 - 4100087492 plus manual or cancellation issues for claims, E-Payables of \$129,909.83 on PeopleSoft 9.2 9100001347 - 9100001403 and Electronic Financial Transactions (EFT) in the amount of \$19,160,360.42 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2. Payment of the sum of \$48,243,810.06 on City General Salary Fund mechanical warrants numbered 51299978 - 51300969 plus manual warrants, agencies warrants, and direct deposits numbered
