BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$30,660,028.46 on PeopleSoft 9.2 mechanical warrants numbered 4100154412 - 4100157712 plus manual or cancellation issues for claims, E- Payables of \$46,262.86 on PeopleSoft 9.2 9100002387 - 9100002435 and Electronic Financial Transactions (EFT) in the amount of \$20,811,446.75 are presented for ratification by the City Council per Chapter RCW 42.24.180.

Section 2. Payment of the sum of \$47,520,425.94 on City General Salary Fund mechanical warrants numbered 51308722- 51309274 plus manual warrants, agencies warrants, and direct deposits numbered 30001
