## BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$37,918,630.74 on PeopleSoft 9.2 mechanical warrants numbered 4100270229- 4100275338 plus manual or cancellation issues for claims, E-Payables of \$71,114.81 on PeopleSoft 9.2 9100004815- 9100004887 and Electronic Financial Transactions (EFT) in the amount of \$20,850,031.88 are presented for ratification by the City Council per RCW 42.24.180.

Section 2. Any act consistent with the authority of this ordinance taken prior to its effective date is hereby ratified and confirmed.
