COUNCIL BILL	

AN ORDINANCE appropriating money to pay certain audited claims for the week of June 21, 2021 through June 25, 2021 and ordering the payment thereof.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Payment of the sum of \$20,686,330.34 on PeopleSoft 9.2 mechanical warrants numbered 4100470711 - 4100472322 plus manual or cancellation issues for claims, E-Payables of \$88,394.81 on PeopleSoft 9.2 9100009507 - 9100009570 and Electronic Financial Transactions (EFT) in the amount of \$61,806,917.77 are presented for ratification by the City Council per RCW 42.24.180.

Section 2. Payment of the sum of \$51,446,713.83 on City General Salary Fund mechanical warrants numbered 51347944- 51348819 plus manual warrants, agencies warrants, and direct deposits numbered 260001

Section 3. Any act consistent with the authority of this ordinance taken prior to its effective date is hereby ratified and confirmed.

Section 4. This ordinance shall take effect and be in force 30 days after its approval by the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it shall take effect as provided by Seattle Municipal Code Section 1.04.020.
