COUNCIL BILL	

- AN ORDINANCE relating to City employment; authorizing the execution of a collective bargaining agreement between The City of Seattle and the Washington State Council of County and City Employees AFSCME, AFL-CIO Local 21C; and ratifying and confirming certain prior acts.
- WHEREAS, the previous agreement between The City of Seattle and the Washington State Council of County and City Employees AFSCME, AFL-CIO Local 21C that established wages, hours, benefits, and other conditions of employment expired on December 31, 2014; and
- WHEREAS, employees represented by the Washington State Council of County and City Employees

 AFSCME, AFL-CIO Local 21C continued to work after the agreement expired on condition that the subject of their wages, hours, benefits, and other conditions of employment continue to be negotiated; and
- WHEREAS, collective bargaining has led to an agreement between The City of Seattle and the Washington State Council of County and City Employees AFSCME, AFL-CIO Local 21C; and
- WHEREAS, separate, future legislation will be forwarded by the City Budget Office to provide department budget appropriation authority to cover compensation authorized in the collective bargaining agreement attached to this ordinance; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. As requested by the Seattle Human Resources Director and recommended by the Mayor, the Mayor is authorized on behalf of The City of Seattle (City) to execute a collective bargaining agreement between the City and the Washington State Council of County and City Employees AFSCME, AFL-CIO Local
