- AN ORDINANCE relating to City employment; authorizing execution of a collective bargaining agreement between The City of Seattle and the International Association of Fire Fighters, Local 27 AFL-CIO-CLC; and ratifying and confirming certain prior acts.
- WHEREAS, the collective bargaining agreement between The City of Seattle and the International Association of Fire Fighters, Local 27 AFL-CIO-CLC expired on December 31, 2021; and
- WHEREAS, employees represented by the International Association of Fire Fighters, Local 27 AFL-CIO-CLC continued to work after the agreement expired on condition that their wages, hours, benefits, and other conditions of employment continue to be negotiated; and
- WHEREAS, collective bargaining has led to a tentative agreement between The City of Seattle and the International Association of Fire Fighters, Local 27 AFL-CIO-CLC; and
- WHEREAS, separate, future legislation will be forwarded by the City Budget Office to provide department budget appropriation authority to cover compensation items authorized in the attached collective bargaining agreement; NOW, THEREFORE,

#### BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. As requested by the Seattle Human Resources Director and recommended by the Mayor, the Mayor is authorized on behalf of The City of Seattle ("City") to execute a collective bargaining agreement between the City and the International Association of Fire Fighters, Local 27 AFL-CIO-CLC, substantially in the form attached to this ordinance as Attachment 1 and identified as "Agreement By and Between The City of Seattle and the International Association of Fire Fighters, Local 27 AFL-CIO-CLC."
